
MORNING ARRIVAL

Student entrance to campus will be at the following two locations: South east gym doors & Maple Ave. pedestrian gate. Temperature checks will be conducted at the above locations. These entry points will open at 6:50 am. Until such time, students will remain in front of the campus, between the Performing Arts Building and Gym and will be supervised by the members of the Administrative Team and Campus Safety Officers on duty.

WHILE ON CAMPUS

Students will be provided the following:

- A grab and go breakfast
- Handwashing stations at various campus locations
- Additional seating and trash receptacles
- Visible COVID-19 safety reminders
- CHS staff providing safety reminders for social distancing
- Increased designated eating space



BETWEEN CLASSES

Direct teacher supervision at the classroom door and social distancing reminders will be conducted before, during, and after each passing period.

DURING CLASS

Daily safety procedures and protocols will be implemented by teachers:

- Use of various Google Suite tools to limit collection of paper from students
- Excessive movement or grouping inside the classroom during daily instruction will be limited
- including the students' one-to-one computer devices



- Use of virtual instructional software when possible,
 - LUNCH TIME



Access beyond the previously identified out-of-bound areas on campus to accommodate for the additional space needed for social distancing. Additionally, students will have access to the following resources during lunch:

- Free grab and go lunch
- Multiple seating areas (SPACE)
- Adult support in the quad to remind students to social distance
- Handwashing stations
- Additional trash receptacles
- COVID-19 safety procedure signage

AFTER SCHOOL

Students will exit the campus from the main campus gates or the Maple pedestrian gate at the end of the school day. Additional gates will remain open to assist with the large numbers of students exiting the campus.
