- Rube Goldberg Machine Competition is a student STEAM competition that fuses engineering critical thinking and creativity
- A Rube Goldberg Machine is a chain reaction machine that solves a simple problem in the most ridiculously inefficient way
- Rube Goldberg Institute has hosted national competitions for the last 30 years
- Rialto Unified students have participated in these competitions since 2018
- Since Rialto Unified students began competing they have won numerous regional and national awards

- To prepare for this competition, students worked for several weeks during their lunch to learn the history of Rube Goldberg.
- They studied simple machines, energy and work.

- The students looked at the possible supplies they would be given on the day of the competition and brainstormed how they could be used in simple machines.
- Coaches were not allowed to instruct or guide students during the competition. They worked exclusively as a student-led team to successfully complete the required tasks.
