FEES AND CHARGES

The Board of Education recognizes its responsibility to ensure that books, materials, equipment, supplies, and other resources necessary for students' participation in the **District's** educational program are made available to them.

No student shall be required to pay any a fees, deposits, or other charges for his/her participation in an educational activity which constitutes an integral fundamental part of the District's educational program, including curricular and extracurricular activities. However, the prohibition does not restrict districts from soliciting for voluntary donations, participating in fundraising activities, or providing prizes or other recognition for participants in fundraising activities. SALE OR LEASE OF DISTRICT-OWNED REAL PROPERTY

The Board of Education believes that the District should utilize its facilities and resources in the most economical and practical manner. The Superintendent or designee shall periodically study the current and projected use of all District facilities to ensure the efficient utilization of space and the effective delivery of instruction.

Prior to the sale or lease of any surplus real property, the Board shall appoint a District advisory committee to advise the Board regarding the use or disposition of schools or school building space which is not needed for school purposes. (Education Code 17388-17389)

Upon determination that District property is no longer needed, or may not be needed until some future time, the Board shall first submit a report to the local planning agency as to what real property the District intends to offer to for sell sale or lease. Not less than 40 days after issuance of the report to the local planning agency, and prior to entering into any agreement for sale or lease of District real property, the Board shall offer to sell or lease district-owned real property in accordance with priorities and procedures specified in law. including, but not limited to, (Education Code 17230, 17387-17391, 17457.5, 17464, 17485-17500; and Government Code 54222, 65402)

Resolution of Intention to Sell or Lease

Before ordering the sale or lease of any real property, the Board shall adopt a resolution by a two-thirds vote of all of its members at a regularly scheduled open meeting. The resolution shall describe the property proposed to be sold or leased in such a manner as to identify it, specify the minimum price or rent, describe the terms upon which it will be sold or leased, and specify the commission or rate, if any, which the Board will pay to a licensed real estate broker out of the minimum price or rental. The resolution shall fix a time, not less than three weeks thereafter, for a public meeting, held at the Board's regular meeting place, at which sealed proposals to purchase or lease will be received and considered. (Education Code 17466)

The Superintendent or designee shall provide notice of the adoption of the resolution and of the time and place of the meeting that will be held to consider bids by posting copies of the resolution, signed by the Board, in three public places not less than 15 days before the date of the meeting. In addition, the notice shall be published at least once a week for three successive weeks before the meeting, in a newspaper of general circulation published in the county in which the District is located, if such a newspaper exists. In accordance with Education Code 17470, the Superintendent or designee shall take reasonable steps to provide notification to the former owners of the property of the District's intent to sell it in accordance with Education Code 17470.

Acceptance/Rejection of Bids

At the public meeting specified in the resolution of intention to sell or lease property, the Board shall open, examine, and declare all sealed bids. Before accepting any written proposal, the Board shall call for oral bids in accordance with law. (Education Code 17472, 17473)

The Board may reject any and all bids, either written or oral, and withdraw the properties from sale when the Board determines that rejection is in the best public interest. If no proposals are submitted or the submitted proposals do not conform to all the terms and conditions specified in the resolution of intention to lease, the Board may lease the property in accordance with Education Code 17477. (Education Code 17476, 17477)

Of the proposals submitted by responsible bidders which conform to all terms and conditions specified in the resolution of intention to sell or lease, the Board shall finally accept the highest bid after deducting the commission, if any, to be paid to a licensed real estate broker, unless the Board accepts a higher oral bid or rejects all bids. (Education Code 17472)

The final acceptance of the bid may be made either at the same meeting specified in the resolution or at any adjourned/continued meeting held within 10 days. Upon acceptance of the bid, the Board may adopt a resolution of acceptance that directs the Board president, or any other Board member, to execute the deed or lease and to deliver the document upon performance and compliance by the successful bidder of all of the terms and conditions of the contract. Whenever State law invests the Board with the power to enter into contracts on behalf of the District, the Board may, by a majority vote, delegate this power to the Superintendent or designee. To be valid or to constitute an enforceable obligation against the District, all contracts must be approved and/or ratified by the Board. (Education Code 17604)

All contracts between the District and outside agencies shall conform to standards required by law and shall be prepared under the direction of the Superintendent or designee.

The Board of Education recognizes its responsibility to enter into contracts on behalf of the District for the acquisition of equipment, supplies, services, and other resources necessary for the achievement of District goals. In exercising this authority to enter into a contract, the Board shall ensure that the District's interest is protected and that the terms of the contract conform to applicable legal standards, including the bidding requirements in Public Contract Code 20111.

When required by law, contracts and subcontracts made by the District for public works or for goods or services shall contain a nondiscrimination clause prohibiting discrimination by contractors or subcontractors. The nondiscrimination clause shall contain a provision requiring contractors and subcontractors to give written notice of their obligations to labor organizations with which they have a collective bargaining or other agreement. (Government Code 12990)

Effective July 1, 2007, The District or a District school shall not enter into or renew a contract for the sale of foods or beverages that do not meet applicable the nutritional standards specified in Education Code 49431049431.7, or 49431.2 5 CCR 15500-15501 or 15575-15578, or 7 CFR 210.11 or 230.12, unless the contract specifies that such sale will occur off campus or outside the time restriction specified in the applicable law. later than one-half hour after the end of the school day and/or off school premises. (Education Code 49431, 49431.2)

In accordance with the dates specified in law, the District or a District school shall not enter into or renew a contract for the sale of beverages that do not meet the nutritional standards in Education Code 49431.5. The sale of these items may be sold on the school premises only if the sale occurs at least one-half hour after the end of the school day. Sales may occur immediately after the school day during a school sponsored activity.

Control systems shall be systematically evaluated and revised to keep pace with the changing responsibilities of management.

If such logos are permitted, the contractor shall present the equipment to the Board as a gift. The gift may be accepted by the Board in accordance with Board Policy and administrative regulation.

Contracts for Digital Storage and Maintenance of Student Records

The District may enter into or renew a contract with a third party for the purpose of providing services, including cloud-based services, for the digital storage, management, and retrieval of student records and/or to provide digital educational software that authorizes a third-party provider of digital educational software to access, store, and use student records. For these purposes, student records include any information maintained by the District that is directly related to a student and any information maintained by the District that is directly related to a student and any information acquired directly from the student through the use of instructional software or applications assigned to the student by a teacher or other District employee, and do not include de-identified information. (Education Code 49073.1)

- 3. A prohibition against the third party using any information in the student record for any purpose other than those required or specifically permitted by the contract
- 4. A description of the procedures by which a parent/guardian or a student age 18 years or older may review personally identifiable information in the student's records and correct erroneous information
- 5. A description of the actions the third party will take, including the designation and training of responsible individuals, to ensure the security and confidentiality of student records
- 6. A description of the procedures for notifying the affected parent/guardian, or the affected student if age 18 years or older, in the event of an unauthorized disclosure of the student's records
- 7. A certification that a student's records shall not be retained or available to the third party upon completion of the terms of the contract and a description of how that certification will be enforced, except that these requirements shall not apply to student-generated content if the student chooses to establish or maintain an account with the third party for the purpose of storing the content.
- 8. A description of how the District and the third party will jointly ensure compliance with the federal Family Education Rights and Privacy Act, 20 USC 1232g
- 9. A prohibition against the third party using personally identifiable information in student records to engage in targeted advertising

Contracts for Personal Services

In order to achieve cost savings, the District may enter into or renew a contract for any personal service that is currently or customarily performed by classified employees, if the contract does not displace school district employees and meets other conditions specified in Education Code 45103.1. To enter into or renew such a contract, the Board shall ensure that the District meets the numerous conditions specified in Education Code 45103.1.

In addition, the District may enter into or renew any contract for personal service without meeting the conditions described above, if any of the following conditions exists: (Education Code 45103.1)

- 1. The contract is for new District functions and the Legislature has specifically mandated or authorized the performance of the work by independent contractors.
- 2. The services contracted are not available within the District, cannot be performed satisfactorily by District employees, or are of such a highly specialized or technical nature that the necessary expert knowledge, experience, and ability are not available through the District.
- 3. The services are incidental to a contract for the purchase or lease of real or personal property, including, but not be limited to, agreements to service or maintain office equipment or computers that are leased or rented.
- 4. The District's policy, administrative, or legal goals and purposes cannot be accomplished through utilization of persons selected pursuant to the regular or ordinary District hiring process.
- 5. The nature of the work is such that the criteria for emergency appointments, as defined in Education Code 45103.1, apply.
- 6. The contractor will provide equipment, materials, facilities, or support services that could not feasibly be provided by the District in the location where the services are to be performed.
- 7. The services are of such an urgent, temporary, or occasional nature that the delay that would result from using the District's regular or ordinary hiring process would frustrate their very purpose.

USE OF SCHOOL FACILITIES

The Board of Education believes that school facilities and grounds are a vital community resource which should be used to foster community involvement and development. Therefore, the Board authorizes the use of school facilities by District residents and community groups for purposes specified in the Civic Center Act, to the extent that such use does not interfere with school activities.

(cf. 6145.5 - Student Organizations and Equal Access)

The Superintendent or designee shall give priority to school-related activities in the use of school facilities and grounds. Other uses authorized under the Civic Center Act shall be on a first-come, first-served basis.

For the effective management and control of school facilities and grounds, the Superintendent or designee shall maintain procedures and regulations that: (Education Code 38133)

- 1. Aid, encourage, and assist groups desiring to use school facilities for approved activities
- 2. Preserve order in school facilities and on school grounds and protect school facilities, designating a person to supervise this talk, if necessary

Subject to prior approval by the Board, the Superintendent or designee may grant the use of school facilities or grounds on those days on which District schools are closed. (Education Code 37220)

(cf. 6115 - Ceremonies and Observances)

There shall be no advertising on school facilities and grounds except as allowed by District policy specified in BP 1325 - Advertising and Promotion.

(cf. 1325 - Advertising and Promotion)

As necessary to ensure efficient use of school facilities, the Superintendent or designee may, with the Board's approval, enter into an agreement for the joint use of any school facilities or grounds. The Board shall approve any such agreement only if it determines that it is in the best interest of the District and the community.

(cf. 1330.1 - Joint Use Agreements)

The Board of Education shall make school facilities and grounds under its jurisdiction available as a civic center to citizens and community groups for the following purposes subject to District policies and regulations:

- 1. Public, literary, scientific, recreational, educational, or public agency meetings.
- 2. The discussion of matters of general or public interest.
- The conduct of religious services.
- 4. Child care or day-care programs to provide supervision and activities for children of preschool and elementary school age.
- 5. The administration of examinations for the selection of personnel or the instruction of precinct Board members by public agencies.
- 6. Supervised recreational activities including, but not limited to, sports league activities that are arranged for and supervised by entities, including religious organizations or churches, and in which youths may participate regardless of religious belief or denomination.
- 7. Mass care and welfare shelters during disasters or other emergencies affecting the public health and welfare, including, but not limited to, the American Red Cross. The Board shall cooperate with these agencies in furnishing and maintaining such services as the Board may deem necessary to meet the needs of the community.
- 8. Other purposes deemed appropriate by the Board.

The Board shall not grant the use of school facilities for any of the following activities:

1.— Any use by an individual, society, group or organization for the commission of any act intended to further any program or movement whose purpose is the overthrow of the Government of the United States or of the State of California by force, violence or other unlawful means.

- 2. Any use of school facilities or ground which is inconsistent with the use of the school facilities or grounds for school purposes or interferes with the regular conduct of school or school work.
- Any use which is discriminatory in the legal sense.
- 4. Any use which involves the possession, consumption or sale of alcoholic beverages or any restricted substances on school property.

Fees for Use of School Facilities

The Board shall adopt a comprehensive schedule of fees to be charged for community use of school facilities and grounds, including, but not limited to, the multipurpose room(s), playing or athletic field(s), track and field venue(s), tennis court(s), and outdoor basketball court(s). The schedule of fees shall be prepared in accordance with 5 CCR 14037-14041. (5 CCR 14041)

(cf. 9320 - Meetings and Notices)

The Board believes that the use of school facilities or grounds should not result in costs to the District. The Superintendent or designee shall charge all groups granted the use of school facilities or grounds under the Civic Center Act an amount not exceeding direct costs determined in accordance with 5 CCR 14037-14041. (Education Code 38134)

The Legislature has amended the Civic Center Act to authorize a school district to charge an organization using school facilities or grounds an amount proportional to the organizations's use of the school facilities or grounds to maintain, repair, restore, and refurbish the school facilities or grounds and to limit the proportional costs related to maintenance, repair, restoration, and refurbishment to only a school's nonclassroom space and grounds. (SB 1404, Section 1(6)(b))

Funds collected under this subparagraph shall be deposited into a special fund that shall only be used for purposes of this section. (SB 1404, Section2 (II)(iii))

In determining direct costs to be charged for community use of each, or each type of, school facility or grounds, the Superintendent or designee shall calculate, in accordance with 5 CCR 14038, the community's proportionate share of the following costs: (Education Code 38134; 5 CCR 14038-14041)

1. Capital direct costs calculated in accordance with 5 CCR 14039, including the estimated costs of maintenance, repair, restoration, and refurbishment of non-classroom space school facilities or grounds

However, capital direct costs shall not be charged to organizations retained by the District or school to provide instruction or instructional activities to students during school hours or for classroom-based programs that operate after school hours, including, but not limited to, after-school tutoring and child care programs. (5 CCR 14037)

2. Operational direct costs calculated in accordance with 5 CCR 14040, including estimated costs of supplies, utilities, janitorial services, other services of District employees and/or contracted workers, and salaries and benefits paid to District employees directly associated with the administration of the Civic Center Act to operate and maintain school facilities and grounds.

Direct cost fees shall not be discounted to any group or organization except when the discount is specifically authorized in the adopted fee schedule. (5 CCR 14041)

Groups shall be charged fair rental value when using school facilities or grounds for entertainment or meetings where admission is charged or contributions solicited and net receipts are not to be expended for charitable purposed or for the welfare of the District's students. (Education Code 38134)

Expending Funds Collected as Capital Direct Costs

Any funds collected as capital direct costs shall be deposited into a special fund to be used only for capital maintenance, repair, restoration, and refurbishment of school facilities and grounds. (5 CCR 14042)

Funds collected under this subparagraph shall be deposited into a special fund that shall only be used for purposes of this section. (SB 1404, Section2 (II)(iii))

Fees for the use of school facilities and grounds shall be charged in accordance with the following classifications:

1. Free Use: Fees for use of facilities will not be charged for any District-sponsored event, group, club, or athleties; in District PTA/PTO or Booster Clubs; or the City of Rialto (via a joint use agreement).

BP 1330(e)

Should any of the above groups prefer to use school facilities at a time when custodial, grounds, security, technical, or lifeguard services are not normally available, the District may charge a fee not to exceed the direct costs. The Principal or designee shall first ensure the availability of other times during the week when the facility could be provided without charge, and this availability shall be pointed out to the free use group.

- 2. Direct Costs Fee: Activities other than those specified for free use or fair rental value and which are included herein through subsequent Board action shall be charged a fee not to exceed direct costs to the District, for groups that use school facilities or grounds under its control during after school hours, and on a Saturday, Sunday or holiday.
 - a. The "direct cost" to maintain school facilities and grounds includes the share of the costs of supplies, utilities, janitorial services, services of school district employees, and salaries paid to school district employees directly to operate and maintain school facilities or grounds that is proportional to the entity's use of the school facilities or grounds.
 - b. The "direct cost" also includes the share of the costs related to maintenance, repair, restoration, and refurbishment of the school facilities or grounds proportional to that entity's use of school facilities or grounds, as specified. (Senate Bill 1404)
 - (1) The charges in "B" above, are applicable to the use of nonclassroom space and school grounds, which includes, but is not limited to, playing fields, athletic fields, track and field venues, tennis courts, and outdoor basketball basketball courts. (Senate Bill 1404)
 - (2) The charges in "B" above are not applicable to classroom based programs that operate after school hours, including, but not limited to, after school programs, tutoring programs, or child care programs; and to organizations retained by the school or school district to provide instruction or instructional activities to pupils during school hours. (Senate Bill 1404)
 - (3) Funds collected under this section shall be deposited into a special fund that shall only bew used for purposes of this section. (Senate Bill1404)

The direct cost fee may be waived for summer and after school recreation programs under the direction of the Rialto City Parks and Recreation Department, provided the City furnishes all the necessary supplies, equipment, supervision, and adequately cleans and secures premises upon completion of daily activity.

3. Fair Rental Value Fee: Groups which use school facilities or grounds for the following activities shall be charged fair rental value:

Entertainment or meetings where admission is charged or contributions solicited and the net receipts are not to be expended for charitable purposes or for the welfare of the District's students. (Education Code 38134)

Priorities of Users

Applications for use of school facilities should be given preference in the following order:

- 1. In school uses (clubs, class events, etc.).
- 2. School support groups, youth and senior citizens groups.
- 3. Public agencies and public affairs groups.
- 4. Community recreational and cultural groups (non-profit).
- 5. Non-profit special interest groups (Audubon Society, etc.).
- Private, non-school connected classes and educational events.
- 7. Profit making or commercial events, out-of-town groups, etc.

Damage to School Property

Groups or persons using school facilities under the provisions of this policy shall be liable for any cleaning or repairs to damaged property caused by the activity. Further use of school facilities may be denied the responsible party.

Regulations for Application and Use of Facilities

The Superintendent shall establish rules and regulations governing application procedures and the use of school facilities, which shall include, but not be limited to:

- Providing encouragement and assistance for any of the users listed above.
- 2. Preserving order and protecting school buildings and school grounds including, as necessary, appointment of a person who shall have charge of the school facilities and grounds for purposes of their preservation and protection.
- 3. Ensuring that use of facilities or grounds under this policy is consistent with school purposes and does not interfere with the regular conduct of school work.

In accordance with Education Code 38136, and in addition to any other forms required by the district, persons or organizations applying for facilities shall submit a statement of information which assures the Board that:

- 1. The facility applied for will not be used for any purposes intended to advocate the overthrow of the Government of the United States or the State of California by force, violence, or other unlawful means.
- The organization applying does not advocate the overthrow of the Government of the United States or the State of California by force, violence, or other unlawful means.
- 3. The organization is not a Communist action organization or Communist front organization required by law to be registered with the Attorney General of the United States

At the Board's discretion, an organization's statement may remain in effect for six months from the date of application.

Member Group

Any persons applying for the use of school property on behalf of any society, group, or organization shall be a member of the applicant group and, unless he/she is an officer of the group, must present written authorization from the applicant group to make the application.

Hold Harmless

All persons or organizations applying for the use of school facilities shall complete and place on file the district's "Hold Harmless" agreement.

Regulations

A copy of the Board's policy and regulations governing use of school facilities shall be issued to those persons or groups requesting use of district facilities or grounds.

Authority

The Superintendent or designee may grant the use of school facilities subject to the provisions of this policy and following conditions:

Charges

Charges levied for use of school facilities and ground shall be according to the hourly fee schedule and begin when the facilities are opened, by qualified District staff, until completion of the activity, including stand by time of school employees assigned to cover the use period.

Payment

A two hour minimum deposit shall be submitted to the Facilities Planning office seven days prior to use. All monies paid in advance are refundable if cancellation notice is given to the Facilities Planning office at least 48 hours before the scheduled activity.

Insurance

Organizations granted use of school facilities may be required to file with District Business Services office prior to use, a Certificate of Insurance naming the Rialto Unified School District as an additional insured on the organization's liability insurance policy.

City/County Ordinances

Any city or county ordinances governing such group activities are considered applicable to activities under these rules and regulations.

Illegal Activities

Gambling, illegal-drugs, alcoholic beverages, and/or tobacco products are not allowed on school facilities or grounds.

Furniture Set-up

Removal of furniture from rooms and/or changes of any kind other than simple room furniture arrangements are not permitted. Special furniture arrangements, setting up chairs, tables, etc., will be charged at the hourly personnel rate.

Custodian

There shall be a custodian in charge at each activity whose duties shall include opening and closing the building and grounds. No charge shall be levied during normal custodial work hours. The Direct Cost Fee will be levied during non regular work hours.

Use of Kitchen Facilities

If the use of the cafeteria equipment or dishes is involved, the kitchen and equipment must be left in a clean and ready condition for normal school operation. The Director of Nutrition Services shall be consulted and arrangements made for a District cafeteria employee to be in supervision of any cafeteria usage.

Limited Usage

The custodian assigned to the activity shall make no other facility or equipment available other than that specifically set forth in the approved application.

Tips/Compensation

Under no circumstances is the custodian to be compensated directly by the persons or organizations using the facilities. Gratuitous tips in any form to school employees when performing services for the District are specifically prohibited.

Non-Available Days

On holidays, it may be necessary to deny use of the facilities if a qualified District employee is not available on that date.

Availability of District Personnel

Use of school facilities by community groups on days other than the above shall be dependent upon the availability of school personnel to assume the responsibility of supervision of school equipment and buildings.

Restroom Facilities

In the case of activities involving a large number of participants, the Facilities Planning Department requires the use of a rented port a potty to be maintained by the participants.

Security/Clean-Up

Costs of providing security and clean up shall be charged to using organizations on a pro-rata basis to be agreed upon by District officials and the reserving organizations.

Restroom Keys

Access to site restrooms is not permitted. The cost of security and custodial services will apply as needed.

Shared Use

No use shall be granted in such a manner as to constitute a monopoly for the benefit of any person or organization.

Six Month Maximum Per Permit

Rialto Unified School District exercises a six month permit maximum to be renewed upon expiration.

Participating principals will receive NISL's Executive Development Program (EDP) training that uses the most recent leadership research from many different professions to develop the capacity to positively impact leadership practice and teacher instructional practice in ways that have the potential to increase the academic achievement of students. In addition to participating in NISL's in-person and online training program, treatment principals will be supported with on-site coaching during their training.

The NISL EDP training and individual coaching for every treatment principal is a \$45,600.00 value of which \$12,600.00 is for the 24 days of leadership training over 15 months and \$33,000.00 for 11 days of on-site coaching. For every principal selected to be in the control group they would also receive similar training at a value of \$5,250.00. This will all be provided at no cost to the district except for mileage reimbursement to the training. All trainings will take place either at the San Bernardino County Superintendent's Office - West End Center in Rancho Cucamonga or at Pomona Unified School District in Pomona.

It is recommended that the Board of Education approve our selected middle school principals at Jehue, Kolb and Frisbie Middle Schools to take part in this leadership training at no cost to the district, except for mileage reimbursement. This training is aligned to the new Common Core initiatives in California and will benefit our schools and our students.

NUTRITION SERVICES FUND

September 9, 2015

A fund is established to demonstrate fiscal accountability and compliance with financerelated legal, budgetary, and contractual provisions and restrictions on the use of public resources.

The Nutrition Services program may be accounted for by using an Enterprise Fund rather than a Special Revenue Fund (Fund 13) even though its primary source of financing comes from Federal and State Child Nutrition Program revenues rather than through the price paid for meals by the students. The California Department of Education recommends that a school district use an Enterprise Fund (Fund 61) to account for its cafeteria operations only if the school district's Governing Board intends to operate its cafeteria program in a manner similar to that employed by private business enterprises and to fully recover all costs of providing services, including depreciation of capital assets.

The San Bernardino County Treasurer requires that the Board of Education approve the opening of all funds. In order to properly reflect the operations of the Nutrition Services program, and to comply with new requirements under GASB 68 (Pension Reform), the District must establish a Fund 61 - Cafeteria Enterprise Fund and, therefore, close the Fund 13 - Cafeteria Special Revenue Fund.

It is recommended that the Board of Education approve the opening of Fund 61-Cafeteria Enterprise Fund and the closure of Fund 13-Cafeteria Special Revenue Fund.

Trane U.S., Inc., is a qualified energy firm with many years of experience and service to K-12 districts, community colleges, and local governments in the development and installation of energy projects. Trane U.S., Inc., has successfully completed the planning, engineering and implementation of Energy Expenditure Plans (EEP) No. 1 and No. 2 for the District since February of 2014, and staff recommends Trane U.S., Inc., to prepare the third Proposition 39 (EEP) No. 3 for the District.

It is recommended that the Board of Education approve an agreement with Trane U.S., Inc., to complete Energy Expenditure Plan (EEP) No. 3 for Proposition 39 in the not-to-exceed amount of \$14,000.00, including all expenses, to be paid from the Proposition 39 Planning Fund (Fund 01 - Resource 6230).

The passage of Proposition 4 (Article XIIIB of the Constitution of the State of California) in November 1979, established constitutional limits on appropriations (Gann Limits) for fiscal years beginning July 1, 1980. These limitations apply only to unrestricted state and local income.

Beginning in 1989-90, the State redefined the state aid that counts toward school district Gann Limits to be "the amount which fills up a district's Gann Limit." Consequently, only districts with extremely high levels of property taxes will be over their Gann Limits.

Education Code sections 1629 and 42123 specify that by September 15 of each year, the governing boards of districts and county offices of education shall adopt a resolution identifying their estimated appropriations limit for the current year and their actual appropriations limit for the preceding year.

The District's actual appropriations limit for the 2014-15 fiscal year is \$224,931,912.78. The District's estimated appropriations limit for the 2015-16 fiscal year is \$230,415,992.27.

It is recommended that the Board of Education adopt Resolution 15-16-12, which declares that the Gann Limit appropriations in the 2014-2015 Unaudited Actuals and 2015-2016 Budget do not exceed the limitations imposed by Proposition 4.

ADOPTION OF RESOLUTION NO. 15-16-13 RELATIVE TO THE RENEWAL OF A TSA/403(B) PLAN

September 9, 2015

The Business Services Division requests approval from the Board of Education to renew an agreement with Schools First Federal Credit Union (SchoolsFirst FCU) and National Benefit Services (NBS) to provide administrative services for the District Tax Shelter Annuity (TSA) Plan 403 (b), effective July 1, 2015, through June 30, 2020.

NBS will act as the third party administrator of the TSA Plan in accordance with the Internal Revenue Code, Section 403(b). NBS will create and maintain a non-specific provider TSA Plan that meets operational, compliance, and administrative guidelines. SchoolsFirst FCU will assist employees regarding their rights, benefits, or any elections under the Provider's plans. SchoolsFirst FCU will, among other duties, facilitate the collection of Provider Agreements and act as the District's liaison to answer questions and inquiries from the Providers. There is no cost to the District.

It is recommended that the Board of Education adopt Resolution No. 15-16-13 to renew an agreement with Schools First Federal Credit Union and the National Benefit Services to provide administrative services for the District Tax Shelter Annuity Plan 403(b), effective July 1, 2015, through June 30, 2020. Adoption of this Resolution by the Board of Education authorizes Mohammad Z. Islam, Associate Superintendent of Business Services, to sign said agreement. There is no cost to the District.

ADOPTION OF RESOLUTION NO. 15-16-13 TSA/403(B) PLAN

September 9, 2015

WHEREAS, the Governing Board of the Rialto Unified School District "District", designated as a public education organization as described in Section 170(b)(1)(A)(ii) of the Internal Revenue Code (IRC), desires to adopt an IRC Section 403(b) Plan in which all employees are permitted to make voluntary salary reductions.

WHEREAS, the members of the Governing Board affirm that each participating employee retains all rights to the individual 403(b) account (or accounts), and, bears the sole responsibility of selection of any of the products or investment options made available by the District. The Board, District officials, or other District employees, make no representations or recommendations and bear no responsibility for any employee's selection of specific annuity products or custodial accounts, and further makes no representations to employees about the advisability, appropriateness or income tax consequences of any 403(b) account to which contributions are made.

THEREFORE, BE IT RESOLVED THAT:

- 1. The 403(b) Plan which, at all times, conforms with the requirements of Section 403(b) of the Internal Revenue Service Code is adopted, and that the following qualified annuities or custodial accounts will be made available for the employees' selection:
 - a) Fixed annuities which are qualified under Section 403(b)(1) of the IRC; and
 - b) Variable annuities which are qualified under Section 403(b)(1) of the IRC; and
 - c) Custodial accounts investing only in regulated investment company stock under Section 403(b)(7) of the IRC.
- 2. Employees of the District are given the opportunity to enter into an amendment of employment contract for the purpose of effecting a reduction in the salary paid to such employee, except as may be limited below. Persons who are not employees are prohibited from participation.

a) X Include □ Exclude Employees who normally work less than 20 hours per week.
 b) X Include □ Exclude Employees whose salary reduction would not exceed \$200 per year.
 c) □ Include X Exclude Employees who are students enrolled and regularly attend classes of the employer.

Conformance: It is the intention of the members of the Governing Board that the District's 403(b) Plan will conform with the applicable federal and state statutory requirements, and that the employee salary reduction contributions to the 403(b) Plan be within eligible limits as set out in IRS regulations as currently stated, or as amended

in the future. Each employee, and not the District or Governing Board, shall be individually responsible for the determination of those eligible limits. Each employee should consult with his/her own tax advisor to determine tax consequences in investing in such 403(b) plans. The Board authorizes SchoolsFirst and National Benefit Services, Inc., the District Superintendent or designee to develop and establish appropriate procedures to insure proper administration of the Plan. The District Superintendent or designee is further authorized to act on the Board's behalf with respect to the Plan.

Compliance: Whereas the Governing Board has been made aware that the Internal Revenue Service has engaged, and continues to engage in the audit of 403(b) plans, and has reported plan defects on a large scale, the Board authorizes SchoolsFirst and National Benefit Services, Inc., to develop appropriate procedures to conduct a compliance review, followed by an ongoing compliance initiative, and to install necessary controls to insure that the 403(b) Plan is operated in conformance with Code and related regulations as currently stated, and as amended in the future; and is further authorized to act on the Board's behalf with respect to the Plan. These procedures shall, include, but are not limited to the following:

- a) Determine eligibility of participants to receive benefits, including loan and hardship distributions, and to make contributions to 403(b) accounts
- b) Monitor applicable contribution limits under IRC 403(b), 402(g) and 415(c), and coordinate efforts to correct any excess contributions between the participant and vendor.

That this Resolution and the attached 403(b) Service Agreement are hereby adopted, approved, and supersede and replace any and all prior resolutions and plans of the District, authorizing the purchase of a TSA/403(b) for its employees.
