#### ITEM: MEMORANDUM OF UNDERSTANDING (MOU) WITH THE INSTITUTE OF ELECTRICAL AND ELECTRONIC ENGINEERS

- Background: Rialto Unified School District STEM ROCS (Robotics and Computer Science) is fortunate to have partnerships with local industries and businesses which support the STEM programs at no cost to the district. We are now fortunate to have our latest partner, the Institute of Electrical and Electronic Engineers (IEEE) who wishes to provide virtual professional development to our teachers as well as provide a one week summer enrichment institute to our students.
- Reasoning: As we implement the Next Generation Science Standards (NGSS) at our middle schools, the standards stress the importance of students having relevant hands on experiences and also incorporating technology in their study of science. IEEE would like to create a Project Based Learning (PBL) unit that explores the science behind waves and their application in the realworld. Teachers and students will have the opportunity to program an Arduino Board to produce ultrasonic waves and learn the various properties of waves such as frequency, wavelength, amplitude and velocity as well as their real life application. IEEE chair, engineers, and STEM student volunteers from IEEE Foothill Young Professionals (FYP) and the IEEE Foothill Women in Engineers (WiE) will assist in the professional development for teachers and the enrichment of their students. Eighth grade science teachers and special education teachers as well as six students from each middle school will be recruited to attend the summer enrichment institute from June 7-11, 2021. All training will be done virtually. The cost associated with this training is paying teachers the extra-duty rate for up to 30 hours each, and to purchase Arduinos kits at a reduced cost of \$60 which was supplied by Bytes and Bots, another IEEE partner. Each middle school is paying for their teachers to attend the training and 12 kits per site so that this PBL unit can be utilized during the regular school year.

Background:	Rialto USD has worked with WestEd since 2003, a premier education research firm, which also provides staff development in the core areas. Some of the trainings that were conducted with WestEd were Science trainings through the K-12 Alliance for Education in 2003 and 2005, the Silicon Valley Math Preject (S)(MI) who are surroutly training Pielto's K 12 teachers and

- through the K-12 Alliance for Education in 2003 and 2005, the Silicon Valley Math Project (SVMI) who are currently training Rialto's K-12 teachers and coaches on mathematics tasks, and the Pre-School and Kindergarten Math study and professional development (2014-2017.) WestEd's study was initially supposed to occur with the first grade teachers during the 2020-2021 school year. It conducted most of the workshops but was unable to collect all the necessary data for the study and got permission from the US Department of Education to extend its study for the 2021-2022 school year. All principals have granted permission for it to continue for another year and all teachers are excited to continue in the study. WestEd will work with any new teachers who will be assigned to the test group in Grade 1 for the 2021-2022 school year.
- Reasoning: WestEd in conjunction with Lawrence Hall of Science (LHS) and SRI International is requesting to continue with its research study of a new literacy-rich Next Generation Science Standards (NGSS) aligned science curriculum for first grade classrooms for the 2021-2022 school year. Funded by the US Department of Education Institute of Education Sciences, the Integrated Science Literacy Curriculum (ISLC) study will investigate the impact of the first grade curriculum on teaching and learning in diverse classroom settings, including those classrooms with English Language Learners. The purpose of this study is to better understand the impact of NGSS curriculum materials for the early grades, with a focus on how curriculum materials can help teachers to create compelling instructional materials for the early grades that motivate and deeply engage their students in science instruction that benefits both science and literacy learning. Accordingly, the study's goals are to understand classroom implementation and the impact of the first grade curriculum on students' achievement and teachers' instructional practices. There will be a data sharing agreement between Rialto USD and WestEd where de-identified data will be shared. Fifteen of Rialto USD's elementary schools attended the presentation conducted by WestEd and showed interest in this study.

The formal study will be done with the test group of teachers during the 2021-2022 school year. WestEd will pay for the substitute costs of the teachers or will pay \$200 per day when substitutes are not needed.

#### ITEM: AGREEMENT WITH EXPLORE LEARNING GIZMOS

- Background: The Next Generation Science Standards (NGSS) require all students to have hands-on experiences in science at all grades. Analysis of our data over the last three (3) years has shown that developing the foundational science and engineering skills related to data analysis and informational writing in middle school students directly impacts high school science success. For high school courses at least 20% of the curriculum must be designated as labs in order to meet the rigor required for "D" level designated by the UC/CSU system.
- Reasoning: During the 2020-2021 school year, due to COVID-19 modifications, Explore Learning Gizmos was utilized in all middle and high school science classes. The gizmos allowed students to conduct virtual labs and simulations, while maintaining student safety. Middle and high school science teachers really liked the program and also stated that their students greatly benefited from the simulated labs. The program also mimics the California Science Test (CAST) in the way the labs are simulated and the questions that it poses to students. Its award winning library of standard aligned investigations in grades 6-12 engaged all students in phenomena. The inquiry based simulations encourage deep understanding and allow for individual students to manipulate variables to obtain unique results which allows for all students to become active learners who participate in building their own understanding. Finally, at a cost of \$3.19 per student it is not possible to curate a comparable tool as it would require substantial professional and curriculum development time and supplemental computer science expertise that would far exceed this cost.
- <u>Recommendation</u>: Approve an agreement with Explore Learning Gizmos for all students in grades 6-12 for virtual labs for three (3) years, effective July 1, 2021 through June 30, 2024.

Background: As part of Assembly Bill 86, COVID-19 Relief Package, school districts were awarded funding through the Expanded Learning Opportunities Grant. School districts must use these funds to implement learning recovery programs, provide supplemental instruction, support for social and emotional well-being, professional development and other supports. Ten percent (10%) of the Expanded Learning Opportunities Grant must be used to expand services provided by paraprofessionals. It is also the intent of law that these funds are used pursuant to subdivision (f) of Education Code section 43522, ten percent of funds may be used for any purpose that supports reopening for in-person instruction, including COVID-19 testing, cleaning and hygienic supplies, and/or facility alterations related to health and safety.

Pursuant to Education Code section 43522(E), school district are required to present the Expanded Learning Opportunities Grant Plan for adoption at a public meeting of the governing board before June 1, 2021.

- Reasoning: The Expanded Learning Opportunities Grant Plan was developed based on the District's assessment of the current state of student learning and social emotional health. The input of various stakeholders was used to prepare the proposed plan. In order to use the Expanded Learning Opportunities Grant, the plan (under separate cover) is presented to the Board of Education for approval.

Background: California's Multi-Tiered System of Support (MTSS) is a comprehensive framework that aligns academic, behavioral, and social-emotional learning in a fully integrated system of support for the benefit of all students. MTSS offers the potential to create needed systematic change through intentional design and redesign of services and supports to quickly identify and match to the needs of all students.

The evidence-based domains and features of the California MTSS framework provide opportunities for districts to strengthen school, family, and community partnerships while developing the whole child in the most inclusive, equitable learning environment thus closing the equity gaps for all students.

<u>Reasoning</u>: California MTSS is built on the premise that universal support must be provided for all students while recognizing that some students may need supplemental support at various times, and a few students may require more intensified support some of the time, to be successful in the most inclusive and equitable learning environment of their grade level peers.

Kordyak Elementary School and Eisenhower High School are working to establish an educational program that aligns their site's Strategic Plan and Single Plan for Student Achievement (SPSA) to the framework of the Multi-Tiered System of Support.

The purpose of the grant is to build capacity for school staff to implement the California MTSS Framework in order to:

- Foster positive school climate
- Improve pupil-teacher relationships
- Increase pupil engagement
- Promote alternative discipline practices

Through the grant, Kordyak Elementary and Eisenhower High will:

 Receive regular Coaching on the California MTSS Framework for two (2) years

- Receive training for 90 percent of eligible staff within an 18 month window through the California MTSS Pathway Certification Course
- Fully implement the California MTSS Framework with a focus of improving School Climate and Conditions
- Use the continuous improvement process and PDSA (Plan-Do-Study-Act) cycles for implementation and system change.

- Reasoning: Family engagement is a necessary component in improving student outcomes. Ready4K delivers a complete whole child curriculum via text messages that are sent three (3) times a week. Messages are designed to support healthy child development by giving families ideas and activities that can be done at home, are accessible to everyone and are tailored to each child's age. Ready4K supports educators by empowering their families to recognize and act on everyday teachable moments. Ready4K is available in Spanish, Chinese, Arabic, Vietnamese and English. The target audience for Ready4K is Rialto Unified School District families with pre-K through 4th grade children. The Ready4K family engagement program will also be promoted and offered to Rialto City families with children ages 0 - 4.

The use of this family engagement platform is directly tied to Rialto Unified School District's Plan, Strategy 5 - we will ensure full engagement of Rialto Unified families.

- <u>Reasoning</u>: To ensure compliance with Federal and State mandates, the District must provide special education and related services as stated in the student's IEP or settlement agreement.

<u>Recommendation</u>: Approve an agreement with Behavioral Autism Therapies, LLC to provide Applied Behavior Analyst (ABA) Aides for six (6) students, effective July 1, 2021 through June 30, 2022.

## ITEM: ACCEPT GRANT FROM CALIFORNIA DEPARTMENT OF FOOD AND AGRICULTURE (CDFA)

- Background: Farm to School Programs are a vital way to improve the health and wellbeing of California schoolchildren through integrated nutrition education and healthy food access. Hundreds of millions of meals are served each year in California schools, and expanding opportunities for local food procurement that is tied to nutrition education is essential for establishing healthy eating habits that children can carry into adulthood. Procurement of more California grown food also supports connecting California's agriculture to California consumers. Rialto USD has taken actions as a district to make environmental sustainability one of their priorities through their school board's Environmental Sustainability Resolution and several initiatives.
- Reasoning: Through work of the Rialto STEM CARES Program and Grounds & Maintenance Department, the district has planted citrus groves on every elementary campus. The Nutrition Services Department has participated in the Fresh Fruits and Vegetables Grant which provides 16 of the 19 elementary schools with healthy options for snacks during the day. This department has also begun the process of procurement with several of the sites (but not all of them). The planned project for Track 1 will expand the work of the Citrus Garden Groves, Rialto STEM Cares Program, Grounds & Maintenance Department, and the Nutrition Services Department. The ultimate goal is to create a unified system that will benefit and connect our students, families, and communities to the cafeterias at school sites.

#### The plan entails the following:

- ✓ Expand procurement practices we have in existence at some of the school sites to every school that has citrus groves and school gardens on their campus.
- Develop a district organization model which includes a Farm to School Coordinator and site Farm to School Liaisons.
- Expand educational and enrichment opportunities for families and students through community partnerships and the creation of curriculum.
- Establish community relationships with local food banks and nonprofit organizations.

The reimbursable grant program will help support local Black, Indigenous, People of Color (BIPOC) farmers and expand healthy food access by

providing grants to schools to establish programs that promote local food procurement and utilization in school meals. It will also support food and agriculture education in classrooms and cafeterias through experiential learning opportunities in school gardens, on farms and through other culinary and agricultural pathways. This funding will also support the Farm to School Working Group to advance farm to school implementation and explore how to create a more resilient and climate-smart food supply in California. In collaboration with the Rialto STEM Cares Environmental Sustainability Coalition, Nutrition Services, Rialto Students Services and Grounds and Maintenance, the environmental grant will assist all 19 elementary schools over the next two years. During the first year, eight RUSD elementary schools will implement environmental sustainability education in their classrooms and school community (i.e. how to grow fruits and vegetables in the schools' gardens, promote healthy eating habits, etc.) and hire their site liaisons. The following year, the remaining elementary schools will be included in the program.

<u>Recommendation</u>: Accept one-time reimbursable grant monies for two years, July 1, 2021 through June 30, 2023, funded by the California Department of Food and Agriculture (CDFA) California Farm to School Innovation Grant through the California Farm to School Incubator Grant Program in the amount of \$286,857.00 for Bemis, Dunn, Fitzgerald, Garcia, Henry, Hughbanks, Kordyak, and Werner Elementary Schools.

#### ITEM: RATIFY AGREEMENT WITH COLLECTION SITES

- Background: On April 14, 2021, the Board of Education approved Resolution No. 20-21-27 to reconvene certain indoor youth sports, in accordance with guidance from the California Department of Public Health (CDPH) and California Interscholastic Federation (CIF).
- <u>Reasoning</u>: Guidance provided by the CDPH specify that a return to play for certain indoor sports, that were not currently authorized by tier assignment, could only resume if the District adheres to additional requirements imposed on collegiate sports, as specified in the Institution of Higher Education Guidance, dated September 30, 2020. The collegiate guidelines specify that student athletes receive periodic Polymerase Chain Reaction (PCR) Test or daily Antigen Test to detect the presence of SARS-CoV-2 (COVID-19).
- <u>Recommendation</u>: Ratify an agreement with Collection Sites to conduct PCR and/or Antigen test of students, including student athletes, to detect the presence of SARS-CoV-2 (COVID-19) from April 15, 2021 through June 30, 2022.
- Fiscal Impact: Not-to-exceed \$200,000 General Fund
