DEBT ISSUANCE AND MANAGEMENT

The Board of Education is committed to long-term capital and financial planning and recognizes that the issuance of debt is a key source for funding the improvement and maintenance of school facilities and managing cash flow. Any debt issued by the district shall be consistent with law and this policy.

(cf. 3000 - Concepts and Roles) (cf. 3460 - Financial Reports and Accountability) (cf. 7110 - Facilities Master Plan) (cf. 7210 - Facilities Financing)

The district shall not enter into indebtedness or liability that in any year exceeds the income and revenue provided for such year, unless two-thirds of the voters approve the obligation or one of the exceptions specified in law applies. (California Constitution, Article 16, Section 18)

When the Board determines that it is in the best interest of the district, the Board may issue debt or order an election to issue debt. The Superintendent or designee shall make recommendations to the Board regarding appropriate financing methods for capital projects or other projects that are authorized purposes for debt issuance. When approved by the Board and/or the voters as applicable, the Superintendent or designee shall administer and coordinate the district's debt issuance program and activities, including the timing of issuance, sizing of issuance, method of sale, structuring of the issue, and marketing strategies.

The Superintendent or designee shall retain a financial advisor, municipal advisor, investment advisor, and other financial services professionals as needed to assist with the structuring of the debt issuance and to provide general advice on the district's debt management program, financing options, investments, and compliance with legal requirements. Contracts for services provided by such advisors may be for a single transaction or for multiple transactions, consistent with the contracting requirements in Education Code 17596. In the event that the district issues debt through a negotiated sale, underwriters may be selected for multiple transactions if multiple issuances are planned for the same project. In addition, the district shall select a legal team on an as-needed basis to assist with debt issuances or special projects.

DEBT ISSUANCE AND MANAGEMENT (continued)

Goals

The district's debt issuance activities and procedures shall be aligned with the district's vision and goals for providing adequate facilities and programs that support student learning and well-being. When issuing debt, the district shall ensure that it:

- 1. Maintains accountability for the fiscal health of the district, including prudent management and transparency of the district's financing programs
- 2. Attains the best possible credit rating for each debt issue in order to reduce interest costs, within the context of preserving financial flexibility and meeting capital funding requirements
- 3. Takes all practical precautions and proactive measures to avoid any financial decision that will negatively impact current credit ratings on existing or future debt issues
- 4. Maintains effective communication with rating agencies and, as appropriate, credit enhancers such as bond insurers or other providers of credit or liquidity instruments in order to enhance the creditworthiness, liquidity, or marketability of the debt
- 5. Monitors the district's statutory debt limit in relation to assessed valuation within the district and the tax burden needed to meet long-term debt service requirements
- 6. When determining the timing of debt issuance, considers market conditions, cash flows associated with repayment, and the district's ability to expend the obtained funds in a timely, efficient, and economical manner consistent with federal tax laws
- 7. Determines the amortization (maturity) schedule which will fit best within the overall debt structure of the district at the time the new debt is issued
- 8. Considers the useful lives of assets funded by the debt issue, as well as repair and replacement costs of those assets to be incurred in the future
- Preserves the availability of the district's general fund for operating purposes and other purposes that cannot be funded by the issuance of voter-approved debt
- 10. Meets the ongoing obligations and accountability requirements associated with the issuance and management of debt under state and federal tax and securities laws

Authorized Purposes for the Issuance of Debt

The district may issue debt for any of the following purposes:

- To pay for the cost of capital improvements, including acquiring, constructing, 1. reconstructing, rehabilitating, replacing, improving, extending, enlarging, and/or equipping district facilities
- 2. To refund existing debt
- 3. To provide for cash flow needs

Pursuant to Government Code 53854, general operating costs, including, but not limited to, items normally funded in the district's annual operating budget, shall not be financed from debt payable later than 15 months from the date of issuance. The district may deem it desirable to finance cash flow requirements under certain conditions so that available resources better match expenditures within a given fiscal year. To satisfy both state constitutional and statutory constraints, such cash flow borrowing shall be payable from taxes, income, revenue, cash receipts, and other moneys attributable to the fiscal year in which the debt is issued.

Authorized Types of Debt

The Superintendent or designee shall recommend to the Board potential financing method(s) that result in the highest benefit to the district, with the cost of staff and consultants considered. Potential financing sources may include:

- Short-Term Debt 1.
- Short-term debt, such as tax and revenue anticipation notes (TRANs), when necessary to a. allow the district to meet its cash flow requirements (Government Code 53850-53858)
- Bond anticipation notes (BANs) to provide interim financing for capital bond projects b. that will ultimately be paid from general obligation bonds (Education Code 15150)

DEBT ISSUANCE AND MANAGEMENT (continued)

- c. Grant anticipation notes (GANs) to provide interim financing pending the receipt of grants and/or loans from the state or federal government that have been appropriated and committed to the district (Government Code 53859-53859.08)
- 2. Long-Term Debt
 - a. General obligation bonds for projects approved by voters (California Constitution, Article 13A, Section 1; Education Code 15100-15262, 15264-15276; Government Code 53506-53509.5)

b. Special tax bonds issued pursuant to the Mello-Roos Community Facilities Act of 1982 (Government Code 53311-53368.3)

- 3. Lease financing, including certificates of participation (COPs)
 - a. Lease financing to fund the highest priority capital equipment purchases when pay-as-you-go financing is not feasible (Education Code 17450-17453.1)
 - b. Lease financing to fund facilities projects when there is insufficient time to obtain voter approval or in instances where obtaining voter approval is either not feasible or unavailable (Education Code 17400-17429)
- 4. Special financing programs or structures offered by the federal or state government, such as Qualified Zone Academy Bonds or other tax credit obligations or obligations that provide subsidized interest payments, when the use of such programs or structures is determined to result in sufficiently lower financing costs compared to traditional tax-exempt bonds and/or COPs
- 5. Temporary borrowing from other sources such as the County Treasurer

COPs, TRANs, revenue bonds, or any other non-voter approved debt instrument shall not be issued by the district in any fiscal year in which the district has a qualified or negative certification, unless the County Superintendent of Schools determines, pursuant to criteria established by the Superintendent of Public Instruction, that the district's repayment of that indebtedness is probable. (Education Code 42133)

Relationship of Debt to District Facilities Program and Budget

Decisions regarding the issuance of debt for the purpose of financing capital improvement shall be aligned with current needs for acquisition, development, and/or improvement of district property and facilities as identified in the district's facilities master plan or other applicable needs assessment, the projected costs of those needs, schedules for the projects, and the expected resources.

The cost of debt issued for major capital repairs or replacements shall be evaluated against the potential cost of delaying such repairs and/or replacing such facilities.

When considering a debt issuance, the Board and the Superintendent or designee shall evaluate both the short-term and long-term implications of the debt issuance and additional operating costs associated with the new projects involved. Such evaluation may include, but is not limited to, the projected ratio of annual debt service to the tax burden on the district's taxpayers and the ratio of annual debt service secured by the general fund to general fund expenditures.

The district may enter into credit enhancement agreements such as municipal bond insurance, surety bonds, letters of credit, and lines of credit with commercial banks, municipal bond insurance companies, or other financial entities when their use is judged to lower borrowing costs, eliminate restrictive covenants, or have a net economic benefit to the financing.

Structure of Debt Issues

The district shall consider the overall impact of the current and future debt burden of the financing when determining the duration of the debt issue.

The district shall design the financing schedule and repayment of debt so as to take best advantage of market conditions, ensure cost effectiveness, provide flexibility, and, as practical, recapture or maximize its debt capacity for future use. Principal amortization will be structured to meet debt repayment, tax rate, and flexibility goals.

For new money debt issuances for capital improvements, the district shall size the debt issuance with the aim of funding capital projects as deemed appropriate by the Board, as long as the issuance is consistent with the overall financing plan, does not exceed the amount authorized by voters, and, unless a waiver is sought and received from the state, will not cause the district to exceed the limitation on debt issuances specified in the California Constitution or Education Code 15106.

To the extent practicable, the district shall also consider credit issues, market factors, and tax law when sizing the district's bond issuance. The sizing of refunding bonds shall be determined by the amount of money that will be required to cover the principal of, any accrued interest on, and any redemption premium for the debt to be paid on the call date and to cover appropriate financing costs.

Any general obligation bond issued by the district shall mature within 40 years of the issuance date or as otherwise required by law. (California Constitution, Article 16, Section 18; Government Code 53508.6)

The final maturity of equipment or real property lease obligations will be limited to the useful life of the assets to be financed but, with respect to a lease purchase of equipment, no longer than a period of ten years. (Education Code 17452)

Method of Sale

For the sale of any district-issued debt, the Superintendent or designee shall recommend the method of sale with the potential to achieve the lowest financing cost and/or to generate other benefits to the district. Potential methods of sale include:

- 1. A competitive bidding process through which the award is based on, among other factors, the lowest offered true interest cost
- 2. Negotiated sale, subject to approval by the district to ensure that interest costs are in accordance with comparable market interest rates
- 3. Private placement sale, when the financing can or must be structured for a single or limited number of purchasers or where the terms of the private placement are more beneficial to the district than either a negotiated or competitive sale

Investment of Proceeds

The district shall actively manage the proceeds of debt issued for public purposes in a manner that is consistent with state law governing the investment of public funds and with the permitted securities covenants of related financing documents executed by the district. Where applicable, the district's official investment policy and legal documents for a particular debt issuance shall govern specific methods of investment of bond-related proceeds. Preservation of principal shall be the primary goal of any investment strategy, followed by the availability of funds and then by return on investment.

(cf. 3430 - Investing)

With regard to general obligation bonds, the district shall invest new money bond proceeds in the county treasury pool as required by law. (Education Code 15146)

The management of public funds shall enable the district to respond to changes in markets or changes in payment or construction schedules so as to ensure liquidity and minimize risk.

Refunding/Restructuring

The district may consider refunding or restructuring outstanding debt if it will be financially advantageous or beneficial for debt repayment and/or structuring flexibility. When doing so, the district shall consider the maximization of the district's expected net savings over the life of the debt issuance and, when using a general obligation bond to refund an existing bond, shall ensure that the final maturity of the refunding bond is no longer than the final maturity of the existing bond.

Internal Controls

The Superintendent or designee shall establish internal control procedures to ensure that the proceeds of any debt issuance are directed to the intended use. Such procedures shall assist the district in maintaining the effectiveness and efficiency of operations, properly expending funds, reliably reporting debt incurred by the district and the use of the proceeds, complying with all laws and regulations, preventing fraud, and avoiding conflict of interest.

The district shall be vigilant in using bond proceeds in accordance with the stated purposes at the time such debt was incurred as defined in the text of the voter-approved bond measure. (Government Code 53410)

When feasible, the district shall issue debt with a defined revenue source in order to preserve the use of the general fund for general operating purposes.

The district shall annually conduct a due diligence review to ensure its compliance with all ongoing obligations applicable to issuers of debt. Such a review may be conducted by general legal counsel or bond counsel. Any district personnel involved in conducting such reviews shall receive periodic training regarding their responsibilities.

In addition, the Superintendent or designee shall ensure that the district completes, as applicable, all performance and financial audits that may be required for any debt issued by the district, including disclosure requirements applicable to a particular transaction.

Records/Reports

At least 30 days prior to the sale of any debt issue, the Superintendent or designee shall submit a report of the proposed issuance to the California Debt and Investment Advisory Commission (CDIAC). Such report shall include a self-certification that the district has adopted a policy concerning the use of debt that complies with law and that the contemplated debt issuance is consistent with that policy. (Government Code 8855)

On or before January 31 of each year, the Superintendent or designee shall submit a report to the CDIAC regarding the debt authorized, the debt outstanding, and the use of proceeds of the issued debt for the period from July 1 to June 30. (Government Code 8855)

The Superintendent or designee shall provide initial and any annual or ongoing disclosures required by 17 CFR 240.10b-5 and 240.15c2-12 to the Municipal Securities Rulemaking Board, investors, and other persons or entities entitled to disclosure, and shall ensure that the district's disclosure filings are updated as needed.

The Superintendent or designee shall maintain transaction records of decisions made in connection with each debt issuance, including the selection of members of the financing team, the structuring of the financing, selection of credit enhancement products and providers, and selection of investment products. Each transaction file shall include the official transcript for the financing, interest rates and cost of issuance on the day when the debt was sold ("final number runs"), and a post-pricing summary of the debt issue. In addition, documentation evidencing the expenditure of proceeds, the use of debt-financed property by public and private entities, all sources of payment or security for the debt, and investment of proceeds shall be kept for as long as the debt is outstanding, plus the period ending three years after the financial payment date of the debt or the final payment date of any obligations or series of bonds issued to refund directly or indirectly all of any portion of the debt, whichever is later.

The Superintendent or designee shall annually report to the Board regarding debts issued by the district, including information on actual and projected tax rates, an analysis of bonding capacity, ratings on the district's bonds, market update and refunding opportunities, new development for California bond financings, and the district's compliance with post-issuance requirements.

TOBACCO

The Board of Education recognizes the serious health risks presented by tobacco use and desires to ensure that, through adoption of consistent policies, District students are made aware of those risks and, to the extent possible, protected from them. The Superintendent or designee shall establish a coordinated school health system which includes a comprehensive behavioral health education component that teaches students the knowledge, skills, and attitudes they need in order to lead healthy lives and avoid high-risk behaviors, such as tobacco use.

The Superintendent or designee shall provide prevention, intervention, and cessation education, information, activities, and/or referrals to District students and shall ensure consistent enforcement of District policies prohibiting student possession and use of tobacco products.

Prohibition Against Tobacco Use

Students shall not possess, smoke, or use tobacco or any product containing tobacco or nicotine while on campus, while attending school-sponsored activities, or while under the supervision and control of District employees. Prohibited products include, but are not limited to, eigarettes, eigars, miniature cigars, clove cigarettes, smokeless tobacco, snuff, chew packets, and betel. (Education Code 48900, 48901)

Students' possession or use of electronic eigarettes, electronic hookahs, and other vapor-emitting devices, with or without nicotine content, that mimie the use of tobacco products is also prohibited.

Smoking means inhaling, exhaling, burning, or carrying of any lighted or heated cigar, cigarette, pipe, tobacco, or plant product intended for inhalation, whether natural or synthetic, in any matter or form, and includes the use of an electronic smoking device that creates aerosol or vapor or of any oral smoking device for the purpose of circumventing the prohibition of smoking. (Business and Professions Code 22950.5; Education Code 48901)

TOBACCO (continued)

Tobacco products include: (Business and Professions Code 22950.5; Education Code 48901)

- 1. A product containing, made, or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed, or ingested by any means, including, but not limited to, cigarettes, cigars, little cigars, chewing tobacco, pipe tobacco, or snuff
- 2. An electronic device that delivers nicotine or other vaporized liquids to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, pipe, or hookah
- 3. Any component, part, or accessory of a tobacco product, whether or not sold separately

These prohibitions do not apply to a student's possession or use of his/her own prescription products. However, student possession or use of prescription products in school shall be subject to the District's policy and regulation for addressing the administration of medications on campus. (Education Code 48900)

Prevention Instruction

The District shall provide developmentally appropriate tobacco-use prevention instruction for students at selected grade levels from K-12 pursuant to Education Code 51202. Such instruction shall be aligned with state content standards and the state curriculum framework for health education and with any requirements of state and/or federal grant programs in which the District participates.

The District may provide or refer students to counseling, intensive education, and other intervention services to assist in the cessation of tobacco use. Such intervention services shall be provided as an alternative to suspension for tobacco possession.

Program Planning

The District's tobacco-use prevention and intervention program shall be based on an assessment of tobacco-use problems in District schools and the community, an examination of existing services and activities in the community, and a determination of high-risk student populations that are most in need of District services.

The Superintendent or designee shall coordinate with the local health department and county office of education in program planning and implementation. He/she may establish an advisory council including students, parents/guardians, District staff, representatives of the local health department and community organizations, law enforcement professionals, and/or others with demonstrated expertise in tobacco prevention and cessation.

The Superintendent or designee also shall coordinate the District's tobacco-use prevention and intervention program with other District efforts to reduce students' use of illegal substances and to promote student wellness.

The Superintendent or designee shall select tobacco-use prevention programs based on the model program designs identified by the California Department of Education (CDE) and may adapt the model to meet District needs. (Health and Safety Code 104420)

The Superintendent or designee shall not accept for distribution any materials or advertisement that promote the use or sale of tobacco products. He/she also shall not accept tobacco-use prevention or intervention funds or materials from the tobacco industry or from any entity which is known to have received funding from the tobacco industry.

Program Evaluation

To evaluate the effectiveness of the District's program and ensure accountability, the Superintendent or designee shall biennially administer the California Healthy Kids Survey or other appropriate student survey at selected grade levels in order to assess student attitudes toward tobacco and student use of tobacco. He/she also shall annually report to the Board, and to the CDE if required, the data specified in Health and Safety Code 104450.

SECONDARY COURSES FOR APPROVAL

April 5, 2017

Education Services requests the Board of Education approve the courses listed below to be offered at the secondary schools during the 2017-2018 school year. These include courses in the areas of Social Studies, Electives and Career Technical Education. These courses were approved in their curriculum committees and were approved at the March 13, 2017 Curriculum Council meeting.

SOCIAL STUDIES

AP Human Geography (10 credits)

Grade 9

AP Human Geography is a college- level course in human geography or cultural geography. Content is presented thematically and is organzied around the disciplines main subfields: economics, cultural geography, political geography and urban geography. This course prepares students for the AP Human Geography Exam. UC "A" Approval Pending.

ELECTIVES

AP Psychology (10 credits)

Grade 11-12

AP Psychology is a one-year introductory course, designed to provide students with a learning experience equivalent to that of a college level Psychology course. Major goals of the course are to expand students' knowledge of Psychology, allow students to apply course concepts to themselves and the surrounding world and to prepare students for the AP Psychology exam. UC "G" Approval Pending.

Exploring Computer Science (10 credits)

Grade 9-10

Exploring Computer Science is designed to develop in students the computational practices of algorithm development, problem solving and programming within the context of problems that are relevant to the lives of todays' students. Students will also be introduced to topics such as interface design, limits of computers, and societal and ethical issues. UC "G" Approval Pending.

Medical Intervention (10 credits)

Grades 9-11

In this course students follow the life of a fictitious family as they investigate how to prevent, diagnose and treat disease. Students explore how to detect and fight infection, screen and evaluate the code in human DNA and evaluate cancer treatment options. Through real-world cases, students are exposed to a range of interventions related to immunology, surgery, genetics, pharmacology, medical devices, and diagnostics. UC "G" Approval Pending.

Biomedical Innovation (10 credits)

Grades 11-12

This is the final course of Project Lead the Way sequence. Students build on the knowledge and skills gained from previous courses to design innovative solutions for the most pressing health challenges for the 21st Century. Students address topics ranging from public health and biomedical engineering to clinical medicine and physiology. Students work on an independent project with a mentor or university advisor, medical facility or research institution. UC "G" Approval Pending.

Senior Seminar (1 credit each semester)

Grade 12

Senior Seminar is a course focused on preparation for post-secondary education. During the first semester students will explore and plan for post-secondary school, writing personal statements, submitting applications and financial aid forms, applying for scholarships and exploring careers and other post-secondary options. During the second semester, students will explore campus life, college issues, and financial education. Class will meet once a week per semester during 7th period and will earn 1 credit. Grade in the class is pass/fail.

CAREER TECHNICAL EDUCATION (CTE)

Introduction to Foods (10 credits)

Grades 9-10

This is an CTE introduction course under the industry sector of Hospitality and Tourism and in the Career Pathway of Food Service and Hospitality. It is designed for students who are interested in understanding the principles of food, nutrition and hospitality. The study and application of food preparation, planning, service and nutrition is addressed in this course. UC "G" Approval Pending.

Advanced Food Preparation (10credits)

Grade 10-12

This is a CTE concentration course under the industry sector of Food Service and Hospitality and in the Career Pathway of Food Services, Dietetics, and Nutrition. It is an advanced laboratory based course that focuses on advanced skills and terminology used in meal management and food preparation. The course focuses instruction on advanced food safety and sanitation, chemical composition of food, reactions of food and food microbiology. UC "G" Approval Pending.

Business Technology (10 credits)

Grades 9-10

This is a CTE introduction course under the industry sector of Business and Finance and in the Career Pathway of Business Management. It provides an in-depth hands-on introduction to business technology used for business communication. Topics include the operating system and communication through digital documents, presentations, data computation and presentation as well as how we represent ourselves through digital media to society. UC "G" Approval Pending.

This is a CTE introduction course under the industry sector of Arts, Media and Entertainment and in the Career Pathway of Production and Managerial Arts. It provides foundational competencies in television, video, computer graphics, and live production, as well as the foundational knowledge in design and design principles to prepare students for employment in the multimedia/communications workforce. UC "G" Approval Pending.

Introduction to Construction (10 credits)

Grades 9-10

This is a CTE introduction course under the industry sector of Building and Construction Trades and in the Career Pathway of Residential and Commercial Construction. It is designed to teach basic skills for the construction trades through a course rich in engaging projects that will generate interest in math and increase students' likelihood of success. UC "G" Approval Pending.

Welding Technology (10 credits)

Grades 9-10

This is a CTE introduction course under the industry sector of Manufacturing and Product Development and the Career Pathway of Production. Students will explore the manufacturing processes common to careers in the welding and related industries. Topics include safety in the shop, and while using machinery, welding processes such as Oxy-fuel, gas welding and brazing, shielded metal arc, gas metal arc and flux cored arc welding. UC "G" Approval Pending.

Child Development and Guidance (10 credits)

Grade 10-11

This is a CTE concentration course under the industry sector of Education, Child Development, and Family Services and in the Career Pathway of Education and Child Development. The course was designed to teach students about the responsibilities of parents; pre-natal development; child growth and development; guidance and discipline; play and learning; health and safety; and changes that affect students. UC "G" Approval Pending.

Careers in Law Enforcement (10 credits)

Grade 9-10

This is a CTE introduction course under the industry sector of Public Services and in the Career Pathway of Public Services. This course introduces the roles and responsibilities, and the hiring and educational requirements of personnel employed in law enforcement organizations at the local, state, and federal levels. A review of major differences and career opportunities within the Army, Navy, Marines, Airforce and Coast Guard will be conducted. UC "G" Approval Pending.

Introduction to Health Care (10 credits)

Grades 9-10

This is a CTE introduction competency-based core course under the industry sector of Health Science and Medical Technology and in the Career Pathway of Patient Care. The course is designed for all students seeking a career in the health care field. It

focuses on the concepts and principles of the structure, function, and systems of the human body in relation to human growth and development. Students will learn the necessary skills for the pathway including legal and ethical responsibilities, cultural considerations in the health care industry, decision making, accepting personal responsibility and self-management. UC "G" Approval Pending.

Health Care Essential I (10 credits)

Grades 9-10

This is a CTE introduction course under the industry sector of Health Science and Medical Technology and in the Career Pathway of Patient Care. It is designed for students interested in a career in the Health Care Industry. Students research career options and learn about a variety of careers in health care, as well as learn the language of medicine. UC "G" Approval Pending.

Exploring Medical Careers (10 credits)

Grades 9-10

This is a CTE introduction course under the industry sector of Health Science and Medical Technology and in the Career Pathway of Patient Care. It is designed to expose students to the Industry Sector of Health Science and Medical Technology and the Career Pathway of Patient Care. It surveys a wide spectrum of Healthcare Occupations and equips them with the entry-level knowledge and skills that apply to a variety of Healthcare Occupations. UC "G" Approval Pending.

Nursing Service (10 credits)

Grades 11-12

This is a CTE course under the industry sector of Health Science and Medical Technology and in the Career Pathway of Patient Care. This course prepares students to incorporate job-specific health career fundamentals with didactic laboratory and clinical competencies. Skill-based learning will allow the students to master hands-on skills necessary for direct patient care. UC "G" Approval Pending.

It is recommended that the Board of Education approve these new courses that will be utilized by all high schools in the district beginning with the 2017-2018 school year.

HIGH SCHOOL HEALTH EDUCATION

April 5, 2017

Education Services requests the Board of Education approve the recommendation from Curriculum Council that beginning with the 2017-2018 school year, 9th graders at each of our high schools not take the Health Course (5 credits), as a requirement for graduation. Health will be gradually phased out, and will still be a graduation requirement for our students who will be in 10th, 11th and 12th grade during the 2017-2018 school year and ending during the 2019-2020 school year. The reasons for this recommended change in graduation requirements are the following:

- Health is not a state requirement for graduation
- Most of our neighboring districts have eliminated Health as a graduation requirement
- As our high schools move to offer courses that align to A-G, Health as a single semester 5 credit course, that is non-A-G aligned, tends to be a master-schedule problem as it is not a year class
- As our schools are offering CTE pathways, a year's CTE introductory course that is a "G" level course will be more useful to our students to start their freshman year, with the rigor of a college elective course

The California Healthy Youth Act (AB329), which took effect January 1, 2016, requires school districts to provide students with integrated, comprehensive, accurate, and inclusive comprehensive sexual health education and HIV prevention education, at least once in high school and once in middle school. This act requires that all students are educated on HIV/AIDS curriculum and issues of gender and identity. All health teachers were trained on this curriculum that was recommended by the State and approved by the Rialto Board of Education during the 2015-2016 school year. This curriculum takes about nine (9) weeks to complete. All 9th graders will receive instruction in this curriculum as one of the rotations in their required Physical Education 9th grade class, which will be taught by a health credentialed teacher in order to be in compliance with the state's regulations.

The plan was discussed and completed with the assistance of Physical Education teachers, Health teachers, and Principals at each high school working together to decide on their school plan. Each school presented their plan at the Health/PE curriculum meeting and the District Curriculum Council voted unanimously on March 13, 2017, to remove Health as a high school graduation requirement.

It is recommended that the Board of Education approve the recommendation from Curriculum Council to remove Health as a high school graduation requirement beginning with the 2017-2018 school year, 9th graders (class of 2021), while it will be phased out with 10th, 11th and 12th graders in the year 2020, and that the required parts of the Health curriculum be taught by a health credentialed teacher as one of the rotations in Physical Education 9th grade class.

MEMORANDUM OF UNDERSTANDING (MOU) WITH CITY OF RIALTO FOR CROSSING GUARD SERVICES

April 5, 2017

The Rialto Unified School District hires and employs crossing guards to provide school crossing guard services for District students of nineteen (19) District elementary schools. The District and the City of Rialto agree to jointly share in the costs of the crossing guard services by reimbursing the District fifty percent (50%) of the total annual estimated costs of the crossing guards.

The District and the City of Rialto believe that crossing guards at specific locations throughout the district are essential for the safety of children attending our schools. Crossing guard services will be performed by persons employed and supervised by the District. Each school site has one to two crossing guards working a morning shift and afternoon shift for a total of three hours per day for 180 school days per year. The direct annual estimated cost per crossing guard based at the minimum hourly rate per hour with benefits is approximately \$6,269.01 for a total annual estimated cost of \$181,801.29 for twenty-nine (29) crossing guards. The annual cost will be adjusted accordingly to the number of crossing guards employed and the cost of minimum wages.

It is recommended that the Board of Education approve a Memorandum of Understanding between the District and the City of Rialto to reimburse the District fifty percent (50%) of the total annual estimated costs for crossing guard services for nineteen (19) District elementary schools, effective July 1, 2017, until such time both parties mutually agree to terminate this Memorandum of Understanding upon thirty (30) days' written notice.
