WAREHOUSE DELIVERY WORKER III

DEFINITION

Under general supervision, organizes, coordinates, and performs lead functions in the District warehousing and distribution operation including Nutrition Services; participates in the receiving, inspecting, storing, and distributing of all materials, goods, foodstuff, equipment and supplies; performs other related work as required and/or assigned.

ESSENTIAL DUTIES

- leads, coordinates, and participates in the receiving, inspection and storage of a variety of nutrition service supplies, materials, and warehouse goods
- assists in the follow-up of shortage, damage, and shipping discrepancies
- reviews, evaluates, and offers suggestions pertaining to the improvement of all District warehouse and distribution operational procedures
- assists in the planning and organization of warehouse space layout and the allocation of storage space and facility usage
- monitors and inspects the warehouse facilities and equipment to insurance adherence to appropriate safety and preventative maintenance standards
- conducts monthly inventory reviews in maintaining appropriate warehouse inventory levels
- implements and maintains manual and automated warehouse and inventory record management, storage, and retrieval systems
- may assist in organizing and conducting warehouse and delivery personnel orientation and in-service training programs
- operates a variety of warehouse storage and distribution equipment
- compiles, prepares, and presents oral and written reports as required
- provides technical input into the performance appraisal of the warehouse and delivery personnel
- occasionally drives a delivery vehicle in the delivery and distribution process
- schedules and routes all incoming and outgoing deliveries
- maintains temperature records for all incoming and outgoing food products and refrigerator/freezer equipment
- monitors and inspects nutrition service warehouse storage facility to ensure adherence to food safety policies and procedures and to Health Department regulations

QUALIFICATIONS

Knowledge of: Methods and procedures pertaining to the warehouse, distribution, and stock control process; educational materials, supplies, and equipment, and nutrition service foods and commodities; inventory planning and control systems and procedures; safety and security practices and procedures; health department regulations concerning storage and transport of food products; food safety.

<u>Ability to</u>: Plan, organize, and implement effective and efficient warehouse and distribution operational procedures; implement and maintain an accurate and effective data management, storage, and retrieval system; effectively participate in the control of warehoused equipment, materials and supplies; compile and present operational reports; understand and follow oral and written directions; establish and maintain cooperative working relationships.

PHYSICAL DEMANDS

The physical requirements indicated below are examples of the physical aspects that this position classification must perform in carrying out essential job functions.

- will frequently exert 50 to 75 pounds of force to lift, carry, push, pull or otherwise move objects
- will walk or stand for extended periods of time, may involve ascending and descending ladders, stairs, scaffolding, and ramps
- must possess the ability to hear and perceive the nature of sound
- must possess visual acuity and depth perception
- must be capable of providing oral information, both in person and over the telephone and other communication devices
- must possess the manual dexterity to operate equipment and use hand tools and work with various objects and materials
- exposure to hot, wet, humid, or windy conditions caused by weather may occasionally be experienced

Reasonable accommodation may be made to enable a person with a disability to perform the essential functions of the job.

EXPERIENCE AND EDUCATION

Experience: Three years of experience, preferably in warehousing, distribution and stock control, including one year in a lead capacity

<u>Education</u>: Verification of a High School diploma, a GED certificate, or a higher degree, supplemental course work or training in warehousing, distribution, and stock control is desirable.

<u>License Requirement</u>: Possession of a valid California Motor Vehicle Operator's License. Possession of a certificate authorizing the operation of forklift equipment.

Condition of Employment: Insurability by the District's liability insurance carrier may be required.
