PROGRAM SPECIALIST (ELO /Expanded Learning Programs) Job Description

DEFINITION

The Expanded Learning Program Specialist will work under the supervision of the Agent Expanded Learning Programs to assist in the development and monitoring of all programs under ELO. It is the responsibility of the Program Specialist to plan, monitor, organize and evaluate each programs' impact and needs.

ESSENTIAL DUTIES

Under the direction of the Agent of Expanded Learning Programs, coordinate and collaborate with school sites, community based organizations to develop and enhance Expanded Learning programming and build and strengthen community relationships. The following are examples of duties and functions:

Coordinate Expanded Learning programs related to program, staffing, safety, registration, staff recruitment, student enrollment maintenance and also perform a variety of support duties for school sites.

- Assists in developing and implementing all aspects of Expanded Learning Programs in accordance with all guidelines; and
 may assist in the general operational duties at individual sites as directed by the agent.
- Plans expanded learning programs, coordinates resources, and assists in evaluating the effectiveness of before school, after school and non-instructional day programs.
- Establish partnerships and plan events to provide students and families the opportunity to attend field trips, participate in clubs, and engage in meaningful activities.
- Provides coordination, consultation and program development.
- Assist in the planning, training, and implementation of ELO programming, including managing the program on-site during program hours.
- Conduct regular site visits to monitor and ensure compliance with program standards. Provides coaching and feedback to site staff.
- Collaborate with agent to plan and implement promotional events
- Support schools and District presentations and meetings
- Support program data tracking and contribute to project reports as required by funding sources.
- Maintains knowledge of current policies and regulations pertaining to ELO guidelines.
- Ensure the program deliverables are met to fulfill the requirements. Responsible for supporting program operations, including organization, prioritization, development of timelines and accountability
- Performs other duties as assigned.
