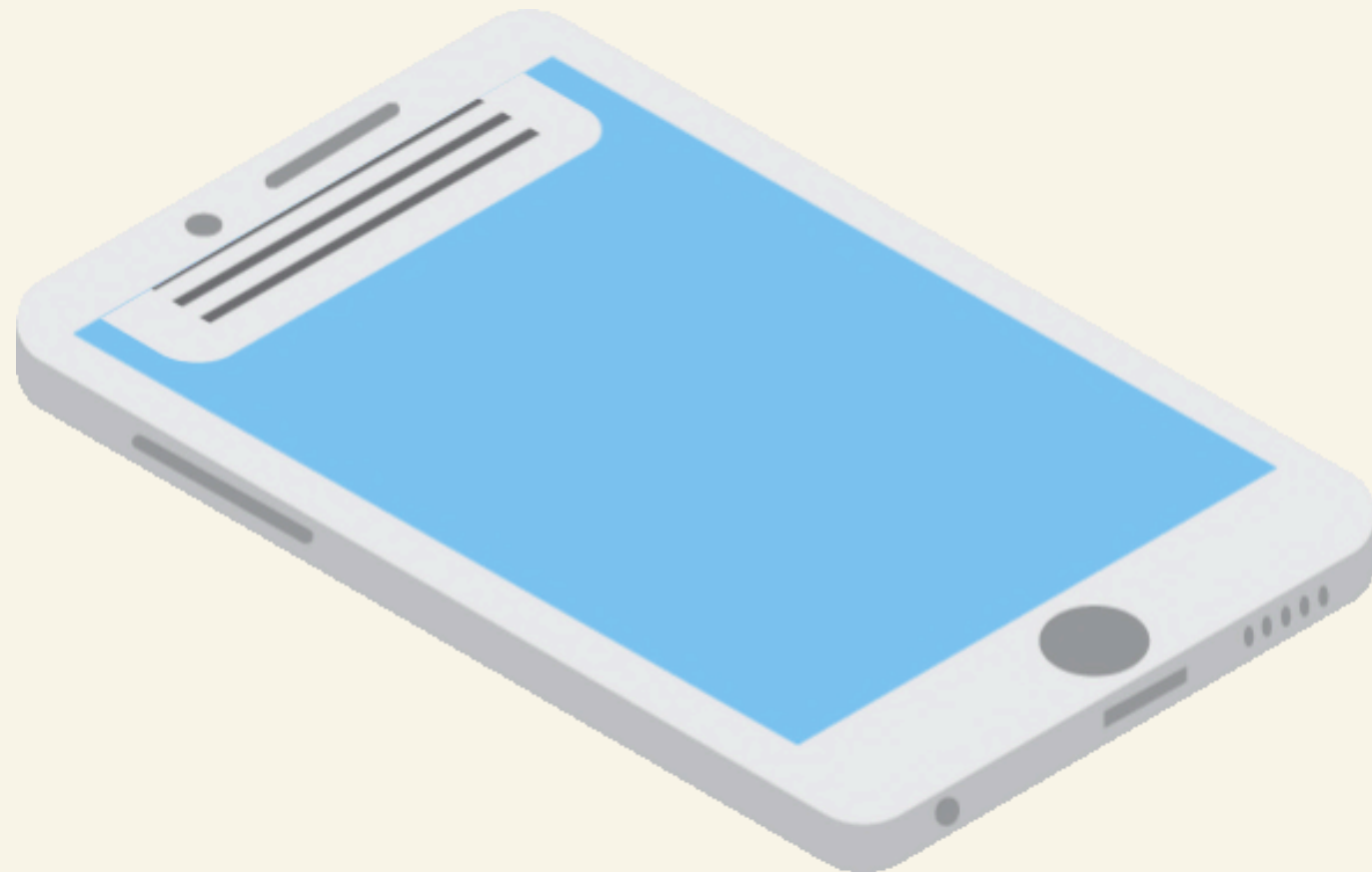

### Student Release Authorization

I acknowledge it is my responsibility to use the Authorized Contact page of this portal to maintain current contact information and active/inactive status for each Authorized Contact.

I understand that in case of emergency, a child may be released to law enforcement personnel if the parent/legal guardian or authorized emergency contact person(s) listed above cannot be reached. I also understand that I may authorize my child be dismissed early from program on both an occasional or recurring basis, including to attend an on-site/off-site program/ activity not supervised by Think Together. 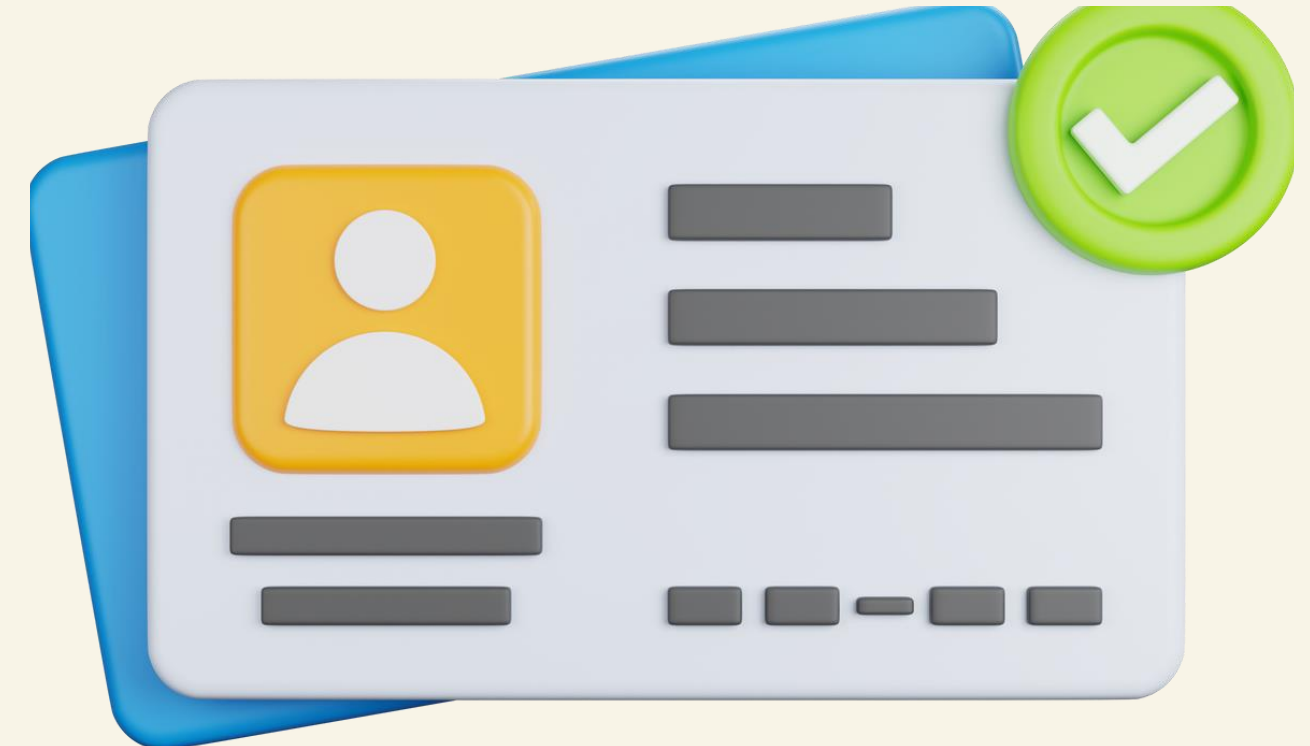
