### **Overview of Requirements**

Changes in the law now require local education agency (school district) to develop and formalize a plan for home to school transportation.

#### **Education Code 39800.1**

Our School District must develop a plan to describe how transportation will be prioritized and offered to students with disabilities, McKinney-Vento (homeless children/youth), and unduplicated pupils in transitional kindergarten, kindergarten, and any of grades 1 to 6, inclusive and pupils who are low income.

#### Education Code 42238.02 Unduplicated pupils

A) English Learner and Foster Youth

The pupil is eligible for a free or reduced-price meal and:

- B) Foster youth
- C) English Learner
- D) English Learner and is a foster youth

- 6. Presentation and adoption of the plan by the Board of Education







### Quality Transportation Services Committee

- The plan requires consultation with students, staff, families, and educational partners.
- The District created a Quality Transportation Services Committee (QTSC) to help develop a plan to describe how we will offer transportation to students with disabilities, McKinney-Vento (homeless children/youth), and unduplicated pupils in transitional kindergarten, kindergarten, and any of grades 1 to 6, inclusive and pupils who are low income.
- The QTSC consisted of families, students, unions, and District staff


