Nadia Morales, Karen Sanchez and Jose Franco, parents – expressed their concerns regarding two fourth grade teachers at Fitzgerald Elementary. Mr. Franco presented a petition to the Board with parent signatures.

Steven Figueroa, Inland Empire Coalition – expressed his concerns regarding the Special Education Department and his support of Norma Del Rio, Special Education Director.

Paula Bailey, parent – expressed her concerns regarding the Special Education Director and racial discrimination.

Rosa Fuentes, parent – congratulated teacher Mark Streeter for saving the life of a child. Ms. Fuentes expressed her concern regarding a transportation issue that caused her student to walk home in the heat.

Russel Silva, community member – spoke regarding the Rialto Community Coalition and events they offer.

Alison Hanna, Brad Malinowski and Terrilynn Bryant, Psychologists – spoke regarding their issues and concerns with the Director of the Special Education. They praised Cabinet, Personnel Department and the two Coordinators of Special Education for their support. Ms. Bryant also spoke regarding their need of new laptops and other materials for the Psychologists.

Celia Zelaya, Mirna Ruiz, and Patricia Ruiz, parents, Amigos Unidos (children with special needs) - spoke in support of Norma Del Rio and requested her position be reinstated as Director of Special Education. They also expressed their concerns regarding the department, lack of support from the District, and requested another Special Education Problem Solving Meeting. Ms. Zelaya reminded the Board of an annual celebration for students with special needs.

Member Martinez made a motion to extend the time for the public to speak on the topic of Special Education. The motion was seconded by Member Ayala, and approved with a unanimous 5-0 vote by the Board of Education.

Marbella Cortez, parent, Amigos Unidos – expressed her concern regarding the County Program at Rialto High School.

Beatriz Gomez, parent – expressed her concerns regarding the Special Education Department and lack of services the students are receiving.

Rafael Chavarria, Special Education Advocate, expressed his concerns regarding the Special Education Department. He praised the Interim Superintendent and Board. Mr. Chavarria requested an advocate for Special Education Parents.

Celia Zelaya, parent, Amigos Unidos – expressed her concerns regarding the hiring of three new speech teachers who she believes were hired without the proper credentials. Ms. Zelaya requested information regarding their background and experience.

TEMPORARY/SUBSTITUTE PERSONNEL

The Board of Education recognizes that substitute and temporary personnel perform an essential role in promoting student achievement and desires to employ highly qualified, appropriately credentialed employees to fill such positions.

(cf. 4112.2 - Certification)

Hiring

The Superintendent or designee shall recommend candidates for substitute or temporary positions for Board approval, and shall ensure that all substitute and temporary employees are assigned in accordance with law and the authorizations specified in their credential.

(cf. 4113 - Assignment)

Substitute personnel may be employed on an on-call, day-to-day basis.

In addition, after September 1 of any school year, the Board may employ substitute personnel for the remainder of the school year for positions for which no regular employee is available. The District shall first demonstrate to the Commission on Teacher Credentialing its inability to acquire the services of a qualified regular employee. (Education Code 44917)

(cf. 4117.14/4317.14 - Postretirement Employment)

Permanent or probationary certificated employees who were laid off pursuant to Education Code 44955 and who have a preferred right of reappointment shall be given priority for substitute service in the order of their original employment. (Education Code 44956, 44957)

(cf. 4117.3 - Personnel Reduction)

Classification

At the time of initial Employment and each July thereafter, the Board shall classify substitute and temporary employees as such. (Education Code 44915, 44916)

TEMPORARY/SUBSTITUTE PERSONNEL (continued)

The Board may classify as substitute personnel a teacher hired to fill the position of a regularly employed person who is absent from service. (Education Code 44917)

To address the need for additional certificated employees when regular District employees are absent due to leaves or long-term illness, the Board may classify a teacher who is employed for at least one semester and up to one complete school year as a temporary employee. Any person whose service begins in the second semester and before March 15 may be classified as a temporary employee even if employed for less than a semester. The Board shall determine the number of persons who shall be so employed, which shall not exceed the identified need based on the absence of regular employees. (Education Code 44920)

The Board also shall classify as temporary employees those certificated persons, other than substitute employees, who are employed to:

- 1. Serve from day-to-day during the first three months of any school term to teach temporary classes which shall not exist after that time, or perform any other duties which do not last longer than the first three months of any school term (Education Code 44919)**
- 2. Teach in special day and evening classes for adults or in schools of migratory population for not more than four months of any school term (Education Code 44919)**

(cf. 6175 - Migrant Education Program)

(cf. 6200 - Adult Education)

- 3. Serve in a limited assignment supervising student athletic activities provided such assignments have first been made available to teachers presently employed in the District (Education Code 44919)**

(cf. 4127/4227/4327 - Temporary Athletic Team Coaches)

- 4. Serve in a position for a period not to exceed 20 working days in order to prevent the stoppage of District business during an emergency when persons are not immediately available for probationary classification (Education Code 44919)**
- 5. Serve only for the first semester because the District expects a reduction in student enrollment during the second semester due to midyear graduations (Education Code 44921)**

For purposes of classifying employees pursuant to item #1 or #2 above, the school year shall not be divided into more than two school terms. (Education Code 44919)

TEMPORARY/SUBSTITUTE PERSONNEL (continued)

Any employee hired to provide services in a categorically funded program or project may be employed for a period less than a full school year. He/she may be classified as a temporary employee if the period of employment will end at the expiration of that program or project. (Education Code 44909)

Salary and Benefits

The Board shall adopt and make public a salary schedule setting the daily or pay period rate(s) for substitute employees for all categories or classes of certificated employees of the District. (Education Code 44977, 45030)

Substitute employees shall not participate in the health and welfare plans or other fringe benefits of the District.

Paid Sick Leave

Any temporary or substitute employee who works for 30 or more days within a year of his/her employment shall be entitled to one hour of paid sick leave for every 30 hours worked. Such employee may begin to use accrued paid sick days on the 90th day of his/her employment, after which he/she may use the sick days as they are accrued. Accrued paid sick days shall carry over to the following year of employment, up to a maximum of 48 hours. (Labor Code 246)

A temporary or substitute employee may use accrued sick leave for absences due to: (Labor Code 246.5)

- 1. The diagnosis, care, or treatment of an existing health condition of, or preventive care for, the employee or his/her family member as defined in Labor Code 245.5***
- 2. Need of the employee to obtain or seek any relief or medical attention specified in Labor Code 230(c) and 230.1(a) for the health, safety, or welfare of the employee, or his/her child, when the employee has been a victim of domestic violence, sexual assault, or stalking***

(cf. 4161.1/4361.1 - Personal Illness/Injury Leave)

(cf. 4261.1 - Personal Illness/Injury Leave)

No employee shall be denied the right to use accrued sick days and the District shall not in any manner discriminate or retaliate against any employee for using or attempting to use sick leave, filing a complaint with the Labor Commissioner, or alleging District violation of Labor Code 245-249. The Superintendent or designee shall display a poster containing required information, provide notice of eligible employees of their sick leave rights, keep records of employees' use of sick leave for three years, and comply with other requirements specified in Labor Code 245-249 and in AR 4161.1/4361.1 - Personal Illness/Injury Leave.

TEMPORARY/SUBSTITUTE PERSONNEL (continued)***Release from Employment/Dismissal***

The Board may dismiss a substitute employee at any time at its discretion. (Education Code 44953)

The Board may dismiss a temporary employee at its discretion if the employee has served less than 75 percent of the number of days the regular schools of the District are maintained *during one school year*. After serving 75 percent of the number of days that District schools are maintained during one school year, a temporary employee may be released as long as he/she is notified, before the last day of June, of the District's decision not to reelect him/her for the following school year. (Education Code 37200, 44954)

(cf. 4112.9/4212.9/4312.9 - Employee Notifications)

Reemployment as a Probationary Employee

Unless released from employment pursuant to Education Code 44954, any person employed for one complete school year as a temporary employee shall, if reemployed for the following school year in a vacant position requiring certification qualifications, be classified as a probationary employee. With the exception of on-call, day-to-day substitutes, if a temporary or substitute employee performs the duties normally required of certificated employees for at least 75 percent of the number of days the regular schools of the District were maintained in the school year and is then employed as a probationary employee for the following school year, his/her previous employment as temporary or substitute employee shall be credited as one year's employment as a probationary employee for purposes of acquiring permanent status. (Education Code 44917, 44918, 44920)

(cf. 4116 - Probationary/Permanent Status)

***Vacant position* means a position in which the employee is qualified to serve and which is not filled by a permanent or probationary employee. It shall not include a position which would be filled by a permanent or probationary employee except for the fact that such employee is on leave. (Education Code 44920, 44921)**

A temporary employee hired pursuant to item #1 or #2 in the section "Classification" above shall be classified as a probationary employee if the duties continue beyond the time limits of the assignment. (Education Code 44919)

A person employed pursuant to item #5 in the section "Classification" above who is then continued in employment beyond the first semester shall be classified as a probationary employee for the entire school year and shall be reemployed to fill any vacant positions in the District for which he/she is certified. Preference for available positions shall be

determined by the Board as prescribed by Education Code 44845 and 44846. (Education Code 44921)

With the exception of on-call, day-to-day substitutes, a temporary or substitute employee who was released pursuant to Education Code 44954 but who has nevertheless served for two consecutive school years, for at least 75 percent of each year, shall receive first priority if the District fills a vacant position for the subsequent school year at the grade level at which the employee served during either year. In the case of a departmentalized program, the employee shall have taught the subject matter in which the vacant position occurs. (Education Code 44918)

~~Certificated personnel who are employed to fill positions of regularly employed persons absent from service on a day to day basis shall be classified as substitute employees. The Board of Education shall adopt and make public the rates of compensation for substitute certificated staff.~~

~~Substitute teachers shall:~~

- ~~1. Have the necessary credential or permit~~
- ~~2. Provide written verification of freedom from active tuberculosis. The verification shall be valid for not more than four years from date of test.~~
- ~~3. Assume the duties assigned to the regular teacher~~
- ~~4. Follow the lesson plan and program of the regular teacher as closely as possible~~

~~Suitable programs for training, assigning, orienting and evaluating the work of substitute teachers shall be provided by the certificated staff under the Superintendent or designee's direction.~~

~~Teachers or counselors who accept temporary assignments to replace persons in management for five consecutive days or more will for each day served receive an increase equal to 10% of their daily rate.~~

~~Within the limits prescribed by law, retired teachers may be employed as substitutes without jeopardizing their retirement salary.~~

HEALTH AND WELFARE BENEFITS

The District shall provide health and welfare benefits for ~~certificated and classified~~ employees in bargaining units in accordance with state and federal law and subject to negotiated employee agreements.

(cf. 4140/4240 - Bargaining Units)
(cf. 4141/4241 - Collective Bargaining Agreement)

Certificated management, administrative, and supervisory employees who are not in bargaining units shall receive the same health and welfare benefits as those specified in the collective bargaining agreement for certificated employees. Classified management, administrative, and supervisory employees who are not in bargaining units shall receive the same health and welfare benefits as those specified in the collective bargaining agreement for classified employees.

(cf. 4300 - Management, Supervisory and Confidential Personnel)

With respect to eligibility to participate in the health benefits plan or the level of health benefits provided, the District shall not discriminate in favor of employees who are among the highest paid 25 percent of all District employees. (26 USC 105; 42 USC 300gg-16)

For purposes of granting benefits pursuant to state law, a registered domestic partner and his/her child shall have the same rights, protections, and benefits as a spouse and spouse's child. (Family Code 297.5)

The Superintendent or designee shall not use or disclose any medical information the District possesses pertaining to an employee without the employee's authorization obtained in accordance with Civil Code 56.21, except for the purpose of administering and maintaining employee benefit plans and for other purposes specified in law. (Civil Code 56.20)

Continuation of Coverage

Retired certificated employees, other employees who would otherwise lose coverage due to a qualifying event specified in law and administrative regulation, and their qualified beneficiaries may continue to participate in the District's group health and welfare benefits in accordance with state and federal law.

CENTER FOR THE COLLABORATIVE CLASSROOM**

Elementary Instructional Services requests that the Board of Education approve an agreement with the Center for the Collaborative Classroom (CCC) to provide training in Systematic Instruction in Phonological Awareness, Phonics, and Sight Words (SIPPS) to all elementary administrators, all elementary teachers, and instructional assistants at all nineteen elementary schools. This training will commence on July 24, 2015 through November, 2015, for a total of eleven training sessions, at a cost not to exceed \$28,600.00, to be paid out of Title I, Program Improvement Reservation funds.

Systematic Instruction in Phonological Awareness, Phonics, and Sight Words (SIPPS) is a decoding program for beginning readers developed by Dr. John Shefelbine of California State University, Sacramento, in collaboration with the Center for the Collaborative Classroom (CCC). The program is aligned with DIBELS Next assessment and is based on two related premises: that comprehension and decoding skills differ in both nature and pace of acquisition, and distinct instructional approaches are required for teaching skills in each area. SIPPS is a stand-alone program that teaches decoding in a way suited to each child's needs and abilities, with the central goal of having students become fluent readers in the shortest possible amount of time, so that students can concentrate on comprehending what they read.

SIPPS is an effective program for teaching all students to decode, and indicates that it is particularly effective for English language learners and socio-economically disadvantaged students. SIPPS has shown to make the largest gains in reading ability for students who typically have the most difficulty learning to read, and therefore, have the greatest need for explicit phonics instruction.

It is recommended that the Board of Education approve an agreement with the Center for the Collaborative Classroom, to provide training in Systematic Instruction in Phonological Awareness, Phonics, and Sight Words (SIPPS), for all elementary administrators, and all elementary teachers and instructional assistants, Kindergarten through Fifth Grade, at all nineteen (19) elementary schools, July through November, 2015, at a cost not to exceed \$28,600.00, to be paid with Title I, Program Improvement Reservation funds.

The Educational Services Division requests approval from the Board of Education to enter into an agreement with Thinkmap, Inc., for one year beginning July 16, 2015 to June 30, 2016.

Thinkmap, Inc., provides a web-based learning program "Vocabulary.com" that uses adaptive technology to offer differentiated vocabulary instructions to students at all levels. It continuously assesses each student and focuses their efforts on words they need to learn. They identify the words students are having the most trouble learning, and work with them until they achieve mastery. In addition to the user interface, they will provide District-wide reporting and ongoing professional development. This will be a support system to our 6th- 12th grade students.

The company has engaging lessons that are scaffolded depending upon the learner. The website allows the teacher to customize, enhance and deliver high caliber mini lessons with rigor in an interactive learning format so that students are engaged. By utilizing the resources available, our core team will be able to assist the District as a whole in supporting the teachers and the transition to the Common Core State Standards and to deliver a systematic approach so that students can master academic vocabulary in all subject areas. The teachers will be able to customize the vocabulary and students can also work within a testing word list to build their knowledge of academic vocabulary as related to any core subject. Teachers can frontload the students with vocabulary they are going to use by subject area and easily integrate additional core areas for interdisciplinary learning for greater understanding. The program is adaptive so the 21st learning style of our students will be supported. The program is comprehensive in that students explore words, definitions, use of, and conjugations of words in a variety of formats.

Thinkmap, Inc., will provide staff development for District staff and teachers. In addition, there is ongoing support through the use of unlimited webinar trainings for each of the schools in the District. Thinkmap, Inc., also tracks all teacher interaction within the service and will provide customized reports as needed. Administrators will be able to access reports through Thinkmap, Inc.'s administration page.

**AMENDMENT NO. 1
AGREEMENT WITH GARCIA AND ASSOCIATES**

July 15, 2015

On January 21, 2015, the Board of Education approved an agreement with Garcia and Associates as the architectural firm to provide required architectural services for the relocation of portable classroom buildings from Kelley Elementary School to Casey Elementary School. The original approved contract amount was not-to-exceed an amount of \$33,900 including allowances for reimbursable expenses and/or unexpected DSA requirements.

Originally, the project involved the relocation of five (5) District-owned portable classrooms from Kelley Elementary School to Casey Elementary School. Three of the five portable classrooms were to replace three leased portable classrooms at Casey Elementary School, and the remaining two portable classrooms were to be added in order to meet the requirements of the State Class Size Reduction program. During the planning phase, adjustments were made to the project scope as follows: 1) the site principal at Casey Elementary School requested one additional portable classroom for the Resource Specialist Program (RSP) program; 2) the architect recommended keeping the leased portable classrooms rather than the District-owned portables at Kelley Elementary School as they were in better condition; 3) additional architectural and civil engineering services were required to determine the least costly reconstruction of the path of travel to meet the Division of the State Architect (DSA) requirements.

The architect and the civil engineer worked with the DSA to resolve the path of travel issue. According to the site map, the shortest path of travel from the portable classrooms was along the parking lot walkway; however this did not meet the DSA standards. Additional surveys and meetings were conducted in order to establish an acceptable path of travel near the playground. The final solution resulted in a substantial cost savings to the project. The proposed fee for the extra services totals \$3,988.00, with a cost breakdown of \$3,188.00 for civil engineering services and \$800.00 for architectural work.

It is recommended that the Board of Education approve Amendment No. 1 to the agreement with Garcia & Associates dated January 21, 2015, for additional services required to complete the relocation of portable classroom buildings from Kelley Elementary School to Casey Elementary School. The additional fee is not-to-exceed \$3,988.00 to be paid from the Developer Fee Fund (Fund 25).
