**CALIFORNIA ASSOCIATION OF BILINGUAL EDUCATION (CABE) BINATIONAL
PROJECT GUIDED LANGUAGE ACQUISITION AND DESIGN (GLAD)**

August 24, 2016

The Educational Services Division requests authorization from the Board of Education to ratify the attendance of four (4) Dual Language Immersion teachers at the *CABE Binational Project GLAD* in Tijuana, Baja California, México, July 20-23, 2016.

The California Association for Bilingual Education (CABE) is nationally recognized for its expertise and contributions to research, instructional practice, and policy for English Learners and their families. CABE is widely respected as the premier provider of cutting edge information and advocacy. In recognition of and support for the nearly 60,000 students that move between residences in California and Baja California, CABE, the *Sistema Educativo Estatal* (SEE), partnered to bring together teachers from both sides of the border to learn more about how to support the academic achievement and linguistic development, in both English and Spanish, of the students they share. In California, teachers in Spanish Dual Immersion classrooms wanted to also be able to improve their academic Spanish.

CABE and CABE Professional Development Services (PDS), along with SEE, entered into a collaboration with the Orange County Department of Education's (OCDE's) National Training Center to have a Project GLAD® certification program serve as a vehicle to accomplish these goals. Recently, thirteen California teachers traveled to Tijuana, México, and, along with twenty teachers from Baja, California, completed the two-day "Research and Theory" training session, the first of two training sessions required to become a certified Project GLAD® teacher through OCDE's National Training Center. This professional development also includes Project GLAD Tier 1 Demonstration workshops in San Bernardino City Unified School District in the fall of 2016.

It is recommended that the Board of Education ratify the attendance of four (4) Dual Language Immersion teachers at the *CABE Binational Project GLAD*, in Tijuana, Baja California, México, July 20-23, 2016. Travel, lodging, meals and registration costs of \$20,140.83 will be paid from Title III funds.

EDUCATIONAL STUDY TRIPS AND LOCATIONS

August 24, 2016

The Board of Education shall annually review a list of locations for authorized study trips submitted to the District Office for consideration of placement on the list. Sites may also submit "one-time" requests for custom trips not placed on the District-approved list.

The following guidelines have been established for educational study trips:

- A. Transportation for approved educational trips is free of cost to students.
- B. Whenever a District employee drives students on school related business, a District-owned vehicle must be used, if available. Employees may drive students in their own car on school-connected business only with prior approval of the Superintendent or designee.
- C. No group shall be authorized to take a study trip or excursion if any student who is a member of such group will be excluded from participation because of lack of funds. The administration may coordinate efforts by community service groups, clubs or other organizations to supply funds for students who need them. (Education Code 35330)

In some cases, fingerprinting is required for parent/guardian chaperones or community members.

It is suggested that the trips requiring admission or other costs be financed by the Associated Student Body (ASB), Parent Teacher Association (PTA), Parent Teacher Organization (PTO), or fund-raising activities. Further, any special requirements for lunch or rest stops will be included in arrangements for the trip.

Visual and Performing Arts - Performances

Study trips that reinforce the "Arts," sometimes are not on the Approved Educational Study Trip List, not scheduled in a timely manner, or are of such a specific or short-term nature that inclusion on the Approved Educational Study Trip List directory is inappropriate; therefore, the following approval process is sanctioned:

First Step: Check the location for appropriateness of student use, i.e., safety, restroom availability, transportation access, snack/meal areas (if applicable).

Second Step: Many of the locations present "Arts" performances or displays that suggest age or grade-level groups. Recognized authorities should suggest grade levels for student participation only, such as County Offices of Education, School Districts or City Governments. Verification is necessary.

Third Step: Once conditions of steps one and two are satisfied, attach a copy of the flyer or announcement with the transportation request and the Study Trip Approval Form to the District Office for approval consideration.

It is recommended that the Board of Education approve the *Educational Study Trips and Locations* for the 2016-2017 school year.

AGREEMENT WITH CAL-STORM COMPLIANCE

August 24, 2016

The Eisenhower High School Stadium Reconstruction and Performing Arts Theater Projects require a Storm Water Pollution Prevention Plan (SWPPP). All active construction projects, one acre or greater, must be compliant with the State Construction General Permit (CGP). Compliance requires that a SWPPP be developed by a licensed Qualified SWPPP Developer (QSD), and that inspections be performed by a licensed Qualified SWPPP Practitioner (QSP) Inspector. The protocol requires weekly pre-rain, during-rain, and post-rain inspections, as well as pH and turbidity testing for Risk Level 2 projects. Currently, no such qualified person is employed by the District.

CAL-Storm Compliance has performed SWPPP and QSP services for various District projects in recent years. The District requested a proposal from CAL-Storm Compliance for the development of a SWPPP for the monitoring and reporting services related to the SWPPP for the Eisenhower High School Stadium Reconstruction and Performing Arts Theater Projects to ensure compliance with the State requirements, thereby, reducing District exposure to potential penalties/fines for non-compliance.

It is recommended that the Board of Education approve an agreement with CAL-Storm Compliance, as the engineering firm, to prepare the State-required Storm Water Pollution Prevention Plan and provide inspections and reports, in accordance with the Construction General Permit, during the construction of the Eisenhower High School Stadium Reconstruction and Performing Arts Theater Projects for a not-to-exceed amount of \$1,420.00 for the Storm Water Pollution Prevention Plan and \$24,000.00 for the Qualified SWPPP Practitioner, state filing, and reporting. The total amount is not-to-exceed \$25,420.00 to be paid from General Obligation Bond - Measure Y Funds.

PIVOT LEARNING PARTNERS

August 24, 2016

Education Services requests the Board of Education approve an agreement with Pivot Learning Partners to provide principal cohort coaching for elementary and secondary administrators for the 2016-2017 school year. Pivot Learning Partners shall provide five coaches to lead six three-hour principal cohort coaching sessions for each of five cohorts of principals, including customized content development for the cohort sessions (30 days).

Pivot Learning representatives, principal coaches, and a project manager and accountability lead will work with site principals to embed what is learned in leadership into their day-to-day practices. The customized coaching sessions will provide:

- Support to principals in consistent implementation of the Leadership Cycle as a mental model for setting vision and goals, and messaging to staff
- Support the principals in building their capacity to implement effective PLCs at their sites
- Support the principals in defining their roles and responsibilities in aligning their leadership goals to the District's Strategic Plan
- Support the principals in using the Cycle of Inquiry during site level PLC meetings to analyze student data and take appropriate steps to increase student achievement
- Facilitate the implementation of a walkthrough and feedback process to assist principals in giving feedback to teachers on best practices and student engagement

It is recommended that the Board of Education approve an agreement with Pivot Learning Partners to provide principals with five coaches to lead six three-hour principal cohort coaching sessions to support coaching sessions for each of five cohorts of principals, and a project management lead to support the project effective September 1, 2016 through May 30, 2017, at a cost not-to-exceed \$65,090.00, to be paid from Title II, Part A (Teacher and Principal Training and Recruiting) Funds.

**AMENDMENT NO. 1
TO AGREEMENT WITH
SUNEDISON GOVERNMENT SOLUTIONS, LLC**

August 24, 2016

On May 6, 2015, the Board of Education approved a Solar Power and Services Agreement with SunEdison Government Solutions, LLC, to design, install, maintain, and operate solar photovoltaic systems on selected school sites and sell energy to the District at a lower flat rate over the term of the Agreement.

On April 21, 2016, SunEdison, Inc., the indirect owner of SunEdison Government Solutions, LLC, declared Chapter 11 bankruptcy. Although SunEdison Government Solutions, LLC, is not a debtor in the bankruptcy, the corporate bankruptcy filing has contributed to the delayed commencement of construction of the solar sites. Additionally, after the District approved the agreement, the applicable engineering requirements for the wind loading of the solar arrays changed unexpectedly, which has increased the costs to construct the solar sites.

Based on the mutual goal of completing the project as soon as possible, the District and SunEdison Government Solutions, LLC, are now entering into Amendment No. 1 to the agreement to establish new milestone dates for commencement and completion of construction of the solar sites, provide for liquidated damages, legal fees, and/or termination should there be significant delays, and increase the kilowatt rate from \$0.117 per kWh to \$0.127 kWh to cover the rise in construction costs due to the wind load change.

SunEdison Government Solutions, LLC, has performed an updated analysis showing the financial and other benefits of entering into Amendment No. 1. An analysis of the solar project, which will be completed in three phases, indicates that the potential net savings to the District over a 20-year term is to be over \$27 million generated from solar installations for at least 28 locations throughout the District.

It is recommended that the Board of Education approve Amendment No. 1 to the agreement with SunEdison Government Solutions, LLC, to establish new milestone dates for commencement and completion of construction of the solar sites, provide for liquidated damages, legal fees, and/or termination should there be significant delays, and increase the kilowatt rate from \$0.117 per kWh to \$0.127 per kWh to cover the rise in construction costs due to the wind load change at no cost to the District. All other terms and conditions shall remain the same as in the original agreement.
