- V. Reports of Officers / Schools
 - a. Elizabeth Alegre-Punchur extends KUDOS to Eco-Hero Presenter at her School, shares resource with link via chat.

- VII. Information Items:
 - a. Overview of DAC (District Advisory Committee) & Purpose
 - i. Presentation by Carol Mehochko.
 - ii. Mr. Avila extends Kudos for team & presenter and offers a little deeper clarification on DAC.
 - 1. Details regarding Title 1 monies, and beneficial programs for targeted Title 1 students.
 - a. Comment by Brenda Parker regarding Parent input being disregarded by District, Dr. Avila acknowledged that budgets & purchases need to be done before school starts, so parent input can't be implemented quickly. Assures that input is reviewed and assures of honest, clear & transparent process. Emphasizes Importance of role f voting members.
 - b. Comment by Monica Thomas regarding difference between school plans at High School level, without follow up on monies spent from previously purchased plans. Dr. Avila admitted that some school will be more organized and transparent than others. Parents should not be asked to vote on items without having prior knowledge on the items being voted on.
 - c. Gina Haymond brought up special tailored programs, ie. for African American students. Carol Mehochko offered some input, as she reviews all plans, and offers feedback to the schools. Dr. Avila addressed as well that with focusing needs based on ethnicity would raise the same needs from other ethnic groups. Thus, separating children based on ethnicity vs. needs would leave more kids behind.
 - 2. Emphasizes single person cannot make decisions. Everything is voted on.
 - 3. Once decisions are made, no 'higher up/individual' can overturn voted on decision.
 - b. Election of Officers (if Quorum is met)
 - i. Nomination and Elections were discussed, and with more information needed on positions and duties, the consensus was to extended voting to be held for the next meeting.
 - c. Review of Title I Survey Results

- i. Presented by Carol Mehochko, regarding the 1,825 responses reviewed. The responses aid with resource distribution, support for parents & students.
- ii. With approximately 25,000 students (7,000 families) District needs more input to get a better idea of the community need.
 - 1. First issue is getting more feedback from families. Dr. Avila is needs to address technical side with reaching families. 30% of calls were incorrect, thus updating phone numbers is needed before next survey.
 - a. Suggestion by Myra Vera-Rizo, towards using Google classroom to reach families with survey response. Note taken by Dr. Avila for that possibility.
